Mayor Adler and City Council Members:

Scott Artmann, Jeff Christensen, and Kean Chan have filed the attached petition for the creation of Williamson County Emergency Services District No. 13 (the "District"). The District is proposed for the purpose of funding emergency medical services in the area. The Petition has been filed with the Commissioners Court of Williamson County, which will hold a public hearing on the Petition in January or February of 2023. Because a portion of the District is within the City of Austin's extraterritorial jurisdiction ("Austin ETJ"), the City must consent to the inclusion of this area within the District in order for it to be included within the District. (Texas Health & Safety Code §775.014). This letter serves as a formal request that the City consent to creation of the proposed District and allow the District to include the Austin City ETJ.

The petitioners respectfully request to be placed on the City's agenda as soon as possible, and before December 22nd at the latest, under an item titled, "Discuss and consider consenting to creation of the proposed Williamson County Emergency Services District No. 13."

A map of the District and the metes and bounds description are included in the attached petition.

The petitioners respectfully request that you consent to including the City of Austin ETJ in Williamson County Emergency Services District No. 13 by adopting a resolution similar to the attached and approving the request in writing.

**TO THE HONORABLE COUNTY JUDGE AND COMMISSIONERS OF SAID COURT:**

NOW COME 100 or more qualified voters who own taxable real property in Williamson County, Texas pursuant to Texas Health & Safety Code, Section 775.011, requesting the creation of an Emergency Services District and would respectfully show the following:

**I.**

That the proposed Williamson County Emergency Services District No. 13 (the "District") will be created and operated under the provisions of Article III, Section 48-e of the Constitution of Texas and Chapter 775 of the Health & Safety Code of the State of Texas.

**II.**

That the name of the proposed District shall be "WILLIAMSON COUNTY EMERGENCY SERVICES DISTRICT NO. 13."

**III.**

That the area of the District will overlap Williamson County Emergency Services District No. 1 located in Williamson County (the "Overlapping District"), and will generally include all or portions of the city limits of the City of Austin, and portions of the extraterritorial jurisdiction of the City of Austin. The boundaries of the District are more particularly described by the description attached as Exhibit "A", which is attached hereto and incorporated herein for all purposes, and generally shown on the attached sketch in Exhibit "B".

#### **IV.**

The District will provide emergency medical services in response to any emergency situation in accordance with the authority granted to emergency services districts under Chapter 775 of the Texas Health & Safety Code, but the District will not provide any services provided by the existing Overlapping District, as set forth in the statement of services to be provided in accordance with Section 775.018(g) of the Texas Health and Safety Code by that district.

#### **V.**

The creation of the District complies with Section 775.0205 of the Texas Health & Safety Code. The petitioners request that the County deliver a copy of this petition to the Board of Commissioners of the Overlapping District and request a statement of services in accordance with Section 775.018(g) of the Texas Health & Safety Code.

#### **VI.**

That Scott Artmann, who resides at 12516 Red Sparrow, Austin, Texas 78729, Jeff Christensen, who resides at 12520 Red Sparrow, Austin, Texas 78729, and Kean Chan, who resides at 12522 Red Sparrow, Austin, Texas 78729, petitioners herein, agree and obligate themselves to pay the cost incident to the formation of the District, including the costs of publishing notices, election costs, and other necessary and incidental expenses, such cost not to exceed one hundred fifty (\$150.00) dollars for Williamson County.

#### **VII.**

The city of Austin is the only municipality whose consent must be obtained under Section 775.014 of the Texas Health & Safety Code.


### VIII.




