agreement for a 6-month extension between the City and Austin Pets Alive. The property, located at 1156 W. Cesar Chavez, Austin, Texas, is currently occupied by Austin Pets Alive (APA) who will continue to use the facility as an animal service center to accommodate APA services to the public.

APA has been an animal welfare partner with the City since 2008 and has been operating out of the Town Lake Animal Center location since 2011. APA serves as a critical partner with the City in maintaining the City's no-kill status, providing adoptable pets for Austinites, and achieving humane care of animals. APA's use of the Town Lake Animal Center facility will provide animal protection and adoption services that are a benefit to the City.

In lieu of a license fee, APA agrees to use the premises and facility solely as an animal services center to improve and maintain the facility and pay utility costs. APA will continue to reimburse the City for all utility costs, within thirty (30) days after APA receives an invoice from the City.
