### Urban Renewal Board

## The Board/Commission mission statement (per the City Code) is:

The Board of Commissioners of the Urban Renewal Agency primary responsibility is to oversee the implementation and compliance of approved Urban Renewal Plans that are adopted by the Austin City Council. An Urban Renewal Plan's primary purpose is to eliminate slum and blighting influence within a designated area of the city.

  - Conducted election of URB Chair and Vice Chair to serve 2021-2022 term of office.
  - Participated in a facilitated discussion, crafted, and approved a new vision statement for the Urban Renewal Plan.
  - Developed and approved recommended modifications to the East 11<sup>th</sup> and 12<sup>th</sup> Street Urban Renewal Plan.
  - Developed and approved recommended modifications to the East 11<sup>th</sup> Neighborhood Conservation Combining District (NCCD).
  - Developed and approved recommended modifications to the East 12<sup>th</sup> Neighborhood Conservation Combining District (NCCD).
  - Approved request to the renew the agreement between the Urban Renewal Agency and the City of Austin concerning the implementation of the Urban Renewal Plan for an additional year.
  - Created a working group to further examine next steps and criteria for the disposition of the URA owned property.

- Reviewed and considered process for property disposition of Urban Renewal Agency owned property.
- Approved agreement with Austin Economic Development Corporation (AEDC) for services to facilitate the property disposition of Urban Renewal Agency owned property.
- Considered and approved license agreement with Capitol View Arts/Rolling Rooster for the use of Urban Renewal Agency owned property at 1100 E 11<sup>th</sup> Street.
- Solicited and considered input from the public on all activities.

- Recommend to City Council one or more proposals received in response to the RFP.
- Solicit and consider input from the public on all activities.
