#### ORDINANCE NO.

AN ORDINANCE WAIVING SUBSECTIONS (B) AND (C) OF CITY CODE SECTION 2-1-22 (MEMBERSHIP TERM AND LIMITATION) FOR THE INDIVIDUALS SPECIFIED IN THE ORDINANCE.

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

**PART 1.** Subsection (B) of City Code Section 2-1-22 (*Membership Term and Limitation*), providing that a board member may serve no longer than eight consecutive years on the same board, excluding service before July 31, 2015, is waived as it pertains to the individuals listed below in order to allow them to complete their current terms of office, which expire February 28, 2025:
