Commissioner Carroll and Commissioner Taniguchi abstained. Commissioner Franco was absent.

The motion that the project Kramer Lane Service Center Substation Improvements complies with the City Design and Sustainability Standards and to recommend a reevaluation of the plant species was approved on Commissioner Whatley's motion, Commissioner Taniguchi second on a 10-0 vote.
