1. Approve the minutes of the Parks and Recreation Board regular meeting of November 28, 2022. Discussion and possible action on the draft Zilker Park Vision Plan public engagement process.
 Board Members received public comment and discussed this item.

The motion to recommend to Austin City Council that the City of Austin Parks Board supports continued public management of Zilker Park, along with increased public funding for and improved management of the park by the Austin Parks and **Recreation Department, and opposes the further privatization of Zilker Park** operations and management; and (a) that the City Council consider appointing a special parks citizen task force, including volunteers from rewilding and others who have been involved with Zilker, to jointly consider the future of Zilker Park and balance that with a goal of recommending priority investments (and dollar amounts of such investments) of all of our metropolitan parks and wildlands, with such recommendations to be consistent with the approved City plans cited above and any approved vision plan for the respective regional parks, and further consistent with the City's goals of equity and inclusion and reducing dependence on travel in and storage of automobiles; and(c) in the event the City Council chooses (b) and appoints a special task force, that the City Council take care to assure that members of such citizen task force are not employed by or otherwise representing the financial interests of any forprofit or nonprofit park concessioner was withdrawn.

At 9:08 p.m., the motion for a five-minute recess was approved on Chair Cottam Sajbel's motion, on a 9-0 vote with one vacancy. Board Member Taylor absent. The Board reconvened at 9:17 p.m.

3. Presentation and discussion and possible action on the findings of a comprehensive lake capacity study of Lady Bird Lake.

Dr. Amanda Masino and Dr. Rohan R. Thompson, Houston-Tillotson University gave a presentation and answered questions.

Presentation, discussion and possible action regarding a recommendation to Austin City Council concerning the creation of a concession in Town Lake Metropolitan Park through the issuance of a Request for Proposal or for the continuation or termination of an existing concessioner in Town Lake Metropolitan Park, including Butler Pitch & Putt, EpicSUP, Expedition School, Lone Star Riverboat Cruises, Rowing Dock, Texas Rowing Center, Waller Creek Boathouse, Zilker Cafe, Zilker Eagle Railroad, and Zilker Park Boat Rentals, for inclusion in the joint report between the Parks and Recreation Board and the Environmental Commission that is provided to the City Council annually. The motion to refer this item to the Parks and Recreation Board Contracts and Concessions Committee was approved on Chair Cottam Sajbel's motion, Board Member Hugman's second on a 9-0 vote with one vacancy. Board Member Taylor absent.
