**ELIGIBILITY REQUIREMENT:** This written promotional examination shall be held in accordance with the Civil Service law and rules, and shall be open to any firefighter who at any time has continuously held for at least two (2) years a position in the Fire Captain classification for which the examination is held.

**ELECTRONIC REGISTRATION FOR WRITTEN EXAM:** As required by Civil Service Commission Rule 7.06, all eligible candidates who intend to take the examination <u>MUST</u> register.

Registration must be made no later than 9:00 AM, May 25, 2023.
