



JOINT SUSTAINABILITY COMMITTEE MEETING MINUTES

REGULAR MEETING January 25, 2023

The Joint Sustainability Committee convened in a hybrid meeting via videoconferencing and at PDC.

1. JOINT SUSTAINABILITY COMMITTEE STRATEGIC PLANNING SESSION

Joint Sustainability Committee 2023 Strategic Planning Session – Jen Cregar, Terra Lumina Consulting (facilitator). The session will help JSC members identify goals and priorities for 2023, and develop an action plan to meet those goals.

Exercise: What do you think the purpose of the JSC is?

- Phillips: Crosses every topic issue in government; wanted to make sure equity is at the forefront, given institutional racism in Austin.
- Wheeler: Cross-pollination; one rep from each commission to report back

- White: JSC makes policy/programmatic recommendations
- Campbell: Has there been success sending recommendations to council?
- White: Mixed, needs follow up from commission members
- Carroll: 70 boards with recommendations, council loses them without follow up

Austin Climate Equity Plan – What worked?

- JSC members were sent a brief survey in advance of the meeting, results included:
 - "...the JSC brings a unique opportunity for various disciplines to convene to develop broader perspective, and identify ways we can align our piece with the city's broader goal of equitable sustainability"
 - \circ "We have a good group of people serving on the commission."
 - "We have received some good presentations."
 - "Agenda topics are good discussions"
- Phillips: equity training + ambassadors have worked
- Leal: development of overarching framework to ensure strategies benefited underserved communities/avoided harm; used by every group. City staff as partners rather than as adversaries.
- Baumer: control over the plan is lost once plan is adopted and handed to departments for implementation; equity considerations are not consistent across city organizations
- White: working groups were effective
- Houser: steering committee/working groups actually got to co-create the plan
- Suarez: easy technical process/online tools

Austin Climate Equity Plan – What hasn't worked?

- Survey results
 - "There are times JSC seems to lack focus..."
 - "...sometimes seems to be a commission in search of a purpose...Initially I understood the 'mission' to be ongoing review and revision of the Climate Plan, but I'm not sure if that's still the primary purpose."
 - "I would prefer if the JSC stuck to a specific, timed agenda and were able to do its business in just a couple hours."
 - "We aren't taking much action."
 - "We aren't digging into the city's policies and programs and making recommendations for what to do next."
 - "We should have more two-way flow of recommendations between the JSC and the various home commissions."
 - "We also need more JSC members reaching out to the city council members who appointed them to urge them to take action when we make recommendations."
 - "It is unclear if our recommendations are making an impact and if council is considering them"
- Phillips: Response from departments, council etc. has led to delays. How seriously has the ACEP been embraced? Lack of willingness to put money behind the plan. There might need to be a separate entity directing funding to the right place (ideas: council task force, external non profit)

• White: Budget recommendations process has not been effective

Mechanisms for action

- Campbell: what is the typical process for action? One commissioner brings a recommendation?
- White: can be organic, up to 9 can meet on the side (less than quorum). Previously, JSC had a working group
- Qureshi lost momentum after the ACEP passed. Oversight is less exciting than implementation

Top priorities, identified by board members

- Help move Austin energy to carbon-free electricity ASAP
- Quantitatively assess plan progress, and focus on strategies with greatest emissions impact
- Create diverse working groups including city staff to support implementation
- Phillips: need a different approach that uses accountability, political influence, other tactical tools. Rather than go back to original approach
- Suarez: working group needed to assess and identify 1-2 key priorities
