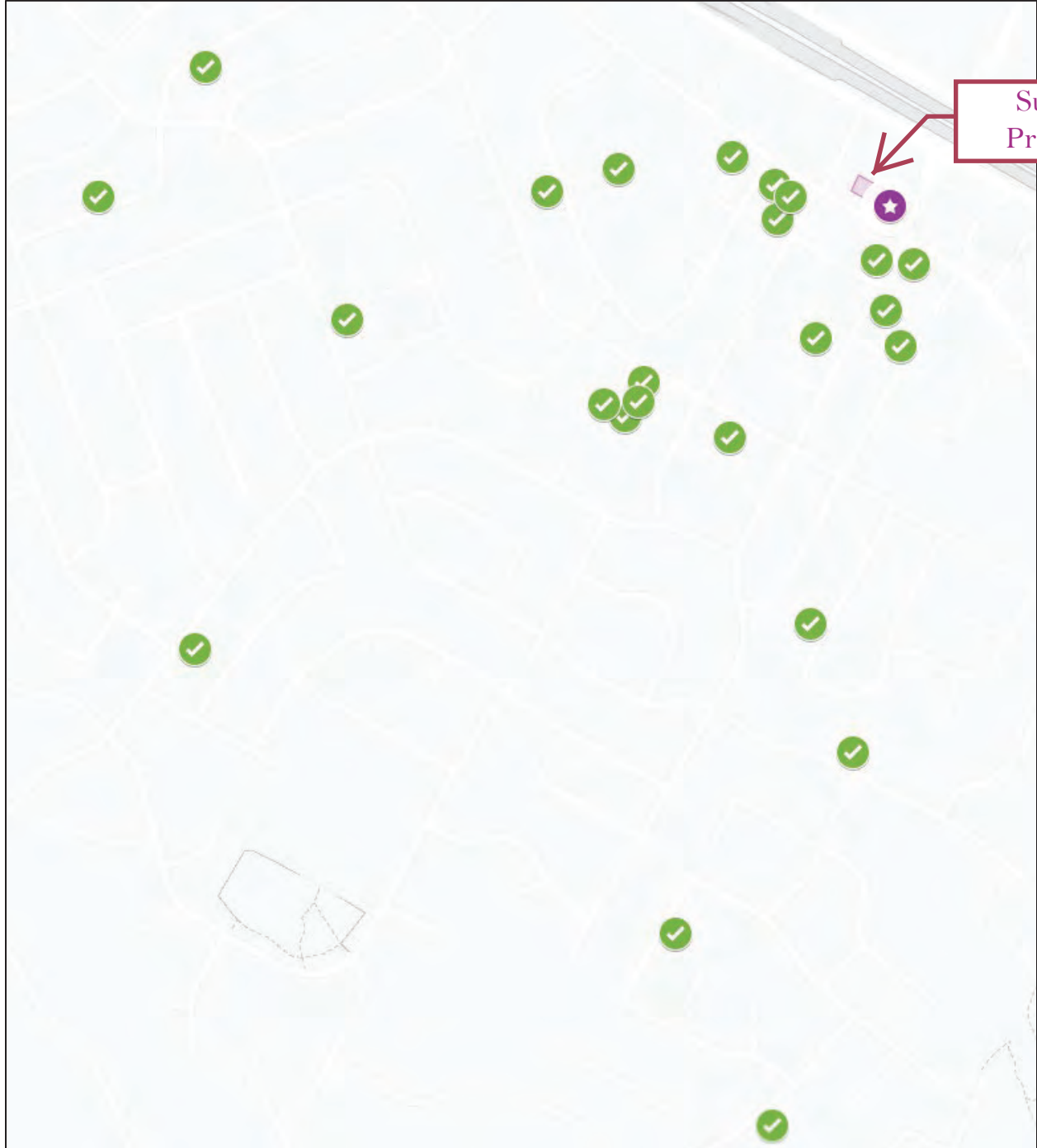


Map Showing Locations of the 26 Signatories of
