BAC Chair Les Case motioned to elevate BAC Member Lansing Pugh to full member for the purpose of this meeting, BAC Vice Chair Spencer Schumacher seconded.

I. Local traffic fatalities reported since previous meeting

BAC Vice-Chair Spencer Schumacher read aloud the names of people whose deaths due to traffic crashes on Austin streets were reported since the BAC and PAC last met: unidentified motorist, pedestrian Kenneth Edward Wilson, passenger Flores Sifuentes motorist Janice

Erickson, pedestrian Maria Monserrat Dubon-Nava, pedestrian Wenwu Cai, motorist Dean Henry Weisner, unidentified pedestrian, and motorist Denise Maxine Cunningham

Austin has had 12 traffic-related deaths in 2023. There had been 10 traffic-related deaths on this date in 2022.

VI. I-35 DEIS Recommendation

BAC Chair Les Case recognized PAC Member Hayden Black Walker to present her draft recommendation.

BAC Vice Chair Spencer Schumacher proposed the following amendment:

BE IT FURTHER RESOLVED, the BAC and PAC request that TxDOT respond to each of the specific concerns outlined in the above "WHEREAS" clauses and that TxDOT outlines how it plans to respond to concerns raised during the public comment.

In response to a concern from PAC Member Daniel Kavelman, PAC Member Hayden Black Walker authored and accepted the following amendment:

Design speeds for the highway lanes, frontage roads, and boulevard are too high. We recommend design speeds for highway lanes should be no higher than 50 mph, and frontage roads and boulevard no higher than 25 mph;
