

# AUSTIN CITY COUNCIL MINUTES

REGULAR MEETING THURSDAY, MARCH 9, 2023

The following represents the actions taken by the Austin City Council in the order they occurred during the meeting. While the minutes are not in sequential order, all agenda items were discussed. The City Council of Austin, Texas, convened in a regular meeting on Thursday, February 9, 2023, at Austin City Hall, 301 W. 2nd Street, Austin, TX and via videoconference.

1. Approve the minutes of the Austin City Council work session of February 21, 2023 and regular meeting of February 23, 2023.

The motion to approve the minutes of the Austin City Council work session of February 21, 2023, and regular meeting of February 23, 2023 was approved on consent without objection. Council Member Harper-Madison was off the dais.

2. Approve an ordinance amending City Code Chapter 10-2 (Emergency Medical Services) to remove references to the Austin Travis County Emergency Medical Services Advisory Board (Board), reassign the duties of the Board, and repeal an obsolete section. Strategic Outcome(s): Safety.

Ordinance No. 20230309-002 was approved on consent without objection. Council Member Harper-Madison was off the dais.

3. Authorize negotiation and execution of an amendment to the interlocal agreement with Travis County to provide emergency medical services in areas of Travis County outside the City's corporate limits and dispatch support services to Travis County's STAR Flight program, in exchange for payment by Travis County. Strategic Outcome(s): Safety.

The motion authorizing negotiation and execution of an amendment to the interlocal agreement with Travis County was approved on consent without objection. Council Member Harper-Madison was off the dais.

4. Authorize execution of a contract for shoebox style luminaires and poles with Techline, Inc., for a term of five years in an amount not to exceed \$750,000. [Note: This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9D (Minority Owned and Women Owned Business Enterprise Procurement Program). For the goods required for this solicitation, there were no subcontracting opportunities; therefore, no subcontracting goals were established]. Strategic Outcome(s): Government that Works for All.

The motion authorizing execution of a contract for shoebox style luminaires and poles with Techline, Inc., was approved on consent without objection. Council Member Harper-Madison was off the dais.

- 5. Authorize negotiation and execution of two contracts for three-phase power transformers with Delta Star, Inc. and Texas Electric Cooperatives, each for up to five years for a total contract amount not to exceed \$60,000,000, divided between the contractors. [Note: This contract is exempt from the City Code Chapter 2-9C (Minority Owned and Women Owned Business Enterprise Procurement Program); therefore, no subcontracting goals were established]. Strategic Outcome(s): Government that Works for All.
  - The motion authorizing negotiation and execution of two contracts for three-phase power transformers with Delta Star, Inc. and Texas Electric Cooperatives, was approved on consent without objection. Council Member Harper-Madison was off the dais.
- 6. Authorize negotiation and execution of a contract for school-based energy conservation education with AM Conservation Group, Inc., for a term of five years for a total contract amount not to exceed \$2,000,000. [Note: This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9C (Minority Owned and Women Owned Business Enterprise Procurement Program) and subcontractor goals were applied to the solicitation. The recommended contractor provided sufficient evidence of good faith efforts and the resulting contract will include 5.40% WBE participation]. Strategic Outcome(s): Government that Works for All.

The motion authorizing negotiation and execution of a contract for school-based energy conservation education with AM Conservation Group, Inc. was approved on consent without objection. Council Member Harper-Madison was off the dais.

7. Authorize negotiation and execution of two contracts for voltage transformers with Priester-Mell & Nicholson, Inc. and Wesco Distribution, Inc. d/b/a Hi-Line Utility Supply Co., LLC a/k/a Power Supply, each for up to five years for total contract amounts not to exceed \$8,000,000, divided between the contractors. [Note: This contract is exempt from the City Code Chapter 2-9D (Minority Owned and Women Owned Business Enterprise Procurement Program); therefore, no subcontracting goals were established]. Strategic Outcome(s): Government that Works for All.

The motion authorizing negotiation and execution of two contracts for voltage transformers with Priester-Mell & Nicholson, Inc. and Wesco Distribution, Inc. doing business as Hi-Line Utility Supply Co., LLC also known as Power Supply was approved on consent without objection. Council Member Harper-Madison was off the dais.

8. Authorize negotiation and execution of a cooperative contract for consulting services for the Greater Austin-Travis County Regional Radio System with Mission Critical Partners, LLC for up to three years for a total contract amount not to exceed \$1,000,000. [Note: This procurement was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9C (Minority Owned and Women Owned Business Enterprise Procurement Program). For the services required for this procurement, there were no subcontracting opportunities; therefore, no subcontracting goals were established]. Strategic Outcome(s): Safety, Mobility.

The motion authorizing negotiation and execution of a cooperative contract for consulting services for the Greater Austin-Travis County Regional Radio System with Mission Critical Partners, LLC was approved on consent without objection. Council Member Harper-Madison was off the dais.

9. Authorize negotiation and execution of a contract for design and development of a secure web-based database and survey platform with Michelle Marshall d/b/a Geospatial Creative, LLC for a term of one year in an amount not to exceed \$100,000. [Note: This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9C (Minority Owned and Women Owned Business Enterprise Procurement Program). For the goods and services required for this solicitation, there were no subcontracting opportunities; therefore, no subcontracting goals were established]. Strategic Outcome(s): Government that Works for All.

The motion authorizing negotiation and execution of a contract for design and development of a secure web-based database and survey platform with Michelle Marshall doing business as Geospatial Creative, LLC was approved on consent without objection. Council Member Harper-Madison was off the dais.

10. Authorize negotiation and execution of four cooperative contracts for pharmaceuticals and medical supplies with McKesson Medical-Surgical, Inc., Henry Schein, Inc., Cardinal Health, and Concordance Healthcare Solutions, LLC, each for a term of five years in an amount not to exceed \$5,010,000, divided among the contractors. [Note: This procurement was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9D (Minority Owned and Women Owned Business Enterprise Procurement Program). For the goods required for this procurement, there were no subcontracting

opportunities; therefore, no subcontracting goals were established]. Strategic Outcome(s): Health and Environment.

The motion authorizing negotiation and execution of four cooperative contracts for pharmaceuticals and medical supplies with McKesson Medical-Surgical, Inc., Henry Schein, Inc., Cardinal Health, and Concordance Healthcare Solutions, LLC, was approved on consent without objection. Council Member Harper-Madison was off the dais.

11. Authorize negotiation and execution of a contract for workforce development and land management activities associated with the maintenance of public natural lands with American YouthWorks, for a term of one year in an amount not to exceed \$2,355,000. [Note: Sole source contracts are exempt from the City Code Chapter 2-9C (Minority Owned and Women Owned Business Enterprise Procurement Program); therefore, no subcontracting goals were established]. Strategic Outcome(s): Health and Environment, Government that Works for All. March 8, 2023 - Recommended by the Water and Wastewater Commission on a 9-0 vote with one absence and one vacancy.

The motion authorizing negotiation and execution of a contract for workforce development and land management activities associated with the maintenance of public natural lands with American YouthWorks was approved on consent without objection. Council Member Kelly abstained. Council Member Harper-Madison was off the dais.

12. Authorize negotiation and execution of a contract for water loss program review, analysis, and optimization with Black & Veatch Corporation, for a term of one year in an amount not to exceed \$200,000. [Note: This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9C (Minority Owned and Women Owned Business Enterprise Procurement Program). For the services required for this solicitation, there were no subcontracting opportunities; therefore, no subcontracting goals were established]. Strategic Outcome(s): Health and Environment, Government that Works for All.

The motion authorizing negotiation and execution of a contract for water loss program review, analysis, and optimization with Black & Veatch Corporation was approved on consent without objection. Council Member Harper-Madison was off the dais.

Interstate Highway 35, Austin, Texas, 78741, from Brook Apartments, L.L.C., a Texas limited liability company, for a total amount not

to exceed \$222,700, including closing costs. District(s) Affected: District 9. Strategic Outcome(s): Government that Works for All. **Withdrawn.** 

15. Approve an ordinance authorizing the negotiation and execution of all documents and instruments necessary or desirable to purchase in fee simple the property, located at 304 Cedarbrook Court, Austin, TX, 78753, 0.23 acres (approximately 9,940 square feet) of land from Wesley Powell and Devin Hennen in an amount not to exceed \$756,400, including closing costs, establishing acquisition and relocation guidelines, and waiving requirements of City Code Chapter 14-3 (Relocation Benefits). District(s) Affected: District 7. Strategic Outcome(s): Health and Environment.

25. Approve a resolution directing the City Manager to establish a charter review commission to propose amendments to the City Charter including, but not limited to, changes in petition requirements. Council Sponsors: Council Member Ryan Alter, Mayor Kirk Watson, Mayor Pro Tem Paige Ellis, Council Member Alison Alter, Council Member Natasha Harper-Madison, Council Member Leslie Pool.

A motion to approve the resolution was made by Council Member Ryan Alter and seconded by Mayor Pro Tem Ellis.

The following amendment was made by Council Member Ryan Alter, seconded by Mayor Pro Tem Alter, and included without objection.

The amendment was to add a bullet point to the final Be It Further Resolved clause:

"Clarification of the outcome of an election where two similar but different ballot measures on the same subject matter both pass."

Resolution No. 20230309-025 was approved as amended on Council Member Ryan Alter's motion, Mayor Pro Tem Ellis' second on a 9-0 vote. Council Member Kelly voted nay. Council Member Harper-Madison was off the dais.

26. Approve a resolution related to restarting the Austin Police Department's Citizen Police Academy. Council Sponsors: Council Member Mackenzie Kelly, Mayor Pro Tem Paige Ellis, Council Member Alison Alter, Council Member Ryan Alter, Council Member José Velásquez.

A motion to approve the resolution was made by Council Member Kelly and seconded by Council Member Alison Alter.

The following amendment was made by Council Member Ryan Alter, seconded by Council Member Kelly, and included without objection.

The amendment was to edit line 25 to read as follows:

"The City Manager is hereby directed to review the feasibility of restarting the Austin Police Department's Community Police Academy as soon as practicable, including:

- Recommendations for how the program's application and screening can be made accessible to a broad and diverse cross-section of the community;
- Recommendations for how the curriculum can be developed, maintained, and delivered in a way that provides opportunities for, and respects, a diversity of opinions regarding police practices and City policy;
- The feasibility of providing college credit or certification hours to individuals who successfully complete the Community Police Academy, and
- Exploring safeguards to prevent political activity such as lobbying or organizing using this publicly funded program and its membership or alumni.

The City Manager is directed to report findings back to the Council by May 22, 2023."

Resolution No. 20230309-026 was approved as amended on Council Member Kelly's motion, Council Member Alison Alter's second on a 10-1 vote. Council Member Qadri voted nay.

27. Approve a resolution directing the City Manager to create a plan to increase the number of direct-current fast charging stations for electric vehicles equitably throughout the City. Approve a resolution accepting the Equitable Transit-Oriented Development (ETOD) Policy Plan; incorporating ETOD Policy Plan tools for the stations within the boundaries of the Northeast Austin District planning process; initiating amendments to Imagine Austin Comprehensive Plan to adopt elements of the ETOD Policy Plan; and initiating amendments to City Code Title 25. Strategic Outcome(s): Economic Opportunity and Affordability.

A motion to approve the resolution was made by Council Member Qadri and seconded by Mayor Pro Tem Ellis.

The following amendment was made by Council Member Vela and seconded by Council Member Qadri.

The amendment was to add the following Be It Further Resolved clause:

"The City Council directs the City Manager to present an implementation plan to clearly identify next steps and identify financing and programmatic support for meeting ETOD goals through implementation of the Policy Toolkit.

The implementation plan should include the following:

- tools prioritized for implementation;
- targeted outcomes for tool implementation;
- timeline for tool implementation;
- identification of funding sources and other resources for tool implementation;
  and
- performance measures to assess tool implementation success.

#### BE IT FURTHER RESOLVED:

As part of the implementation plan, the City Council directs the City Manager to do the following:

- Coordinate with the Austin Transit Partnership, Capital Metro, the City of Austin's Project Connect Office, and the Project Connect Community Advisory Committee to develop population targets for areas around the light rail stations, both individually and as an average along the light rail corridor, with the goal of maximizing the project's score on grant applications in order to maximize federal grant funding competitiveness.
- Coordinate with the Austin Transit Partnership, Capital Metro, and the City of Austin's Project Connect Office to evaluate the ETOD Station Area Planning Priorities matrix to prioritize light rail investments and the need for demonstrated outcomes on federal grant applications.
- Explore value capture tools such as tax increment financing to fund items such as affordable housing, pedestrian and bicycle improvements, parks, regional water quality facilities, utility relocation, and other necessary infrastructure investments.
- Provide scenarios including timelines and staffing needs for developing ETOD station area plans, including scenarios that utilize resources from partnering agencies.
- Provide a clear definition and scope of the ETOD overlay to ensure robust affordable housing creation, preservation, and tenant protections in return for relaxed development standards and other programs and incentives.

#### BE IT FURTHER RESOLVED:

The City Council directs the City Manager to provide an update to the Housing and Planning Committee and Mobility Committee no later than May 26th, and to present a full implementation plan to the Housing and Planning Committee and Mobility Committee no later than September 12th."

The following amendment to Council Member Vela's amendment was made by Council Member Alison Alter, seconded by Council Member Vela.

The amendment was to edit the third bullet point of the second Be It Further Resolved clause to read as follows:

"Explore value capture tools such as tax increment financing to incentivize or fund items such as affordable housing, pedestrian and bicycle improvements, parks, regional water quality facilities, utility relocation, and other necessary infrastructure investments."

The amendment was included without objection. Council Member Harper-Madison was off the dais.

Council Member Vela's amendment as amended was included without objection. Council Member Kelly abstained. Council Member Harper-Madison was off the dais.

The following amendments were made by Mayor Pro Tem Ellis and seconded by Council Member Vela.

The amendment was to edit the Draft ETOD Policy Plan (Attachment A) as follows:

On page 29, under Future Station Area Planning Priorities Approach, amend Criteria 2 to read:

"Criteria 2: Presence of Publicly Owned Land: Station areas with land owned by the City of Austin and CapMetro should be high priority for planning services because, should it be decided that some of this land is no longer needed for agency operations, these publicly owned sites could be catalysts for increasing ridership and affordable housing. Station areas with land that is owned by another local governmental entity and anticipated to be developed or redeveloped in the next five years should also be high priority for planning services. To determine the station areas containing City and CapMetro owned land, staff used 2021 Travis County Appraisal Data, embedded in the parcel ownership map on the ETOD Interactive Conditions Analysis Dashboard, to calculate the share of City and CapMetro-owned land in each station area and prioritized station areas with larger shares of publicly owned land."

On page 36, rename the "Oak Hill" Bus Rapid Transit Station as "Pinnacle," change its Priority for Planning level from Medium to High, and move that line of the table to page 34 to be grouped appropriately.

In Appendix E: Station Area Planning Priority Methodology (pages A14 - A23), make conforming changes as appropriate

Edit lines 107-109 of the Draft Resolution to read as follows:

"WHEREAS, in consideration of the timing of the initial investment in rail under the Project Connect Transit System, rail is first in priority for commencement of all implementation activities, except concurrent commencement may occur for a MetroRapid line that has not yet been awarded federal funding and is assessed to rate uncompetitively for federal funding on the FTA's land use and economic development criteria;"

Add the following Whereas clauses between line 133 and 134:

"WHEREAS, the City of Austin partners with HousingWorks Austin to annually analyze our success in meeting our Austin Strategic Housing Blueprint goals, and these Scorecards document that we regularly fall short on Goal 1: Affordable Homes in Each District and, within Goal 5, on New Affordable Housing near High-Opportunity Areas; and WHEREAS, MetroRapid Bus lines will dramatically extend the reach of Project Connect's high-capacity transit system into far more neighborhoods than rail will serve alone, including high-opportunity areas where affordable housing could be more easily produced following an ETOD planning process and the application of ETOD development regulations; and"

A motion to take up the item at 11:50 a.m. was made by Council Member Alison Alter, seconded by Council Member Fuentes, and accepted without objection.

The following amendment to Mayor Pro Tem Ellis' amendment was made by Council Member Alison Alter, seconded by Mayor Pro Tem Ellis.

The amendment was to add on lines 107-109 to read as follows:

"...FTA's land use and economic development criteria and rates high within the bus rapid transit prioritization table;"

The amendment was included without objection.

Since January 2023, I tried to alert the Austin Code department, I call 311, I called my officer district representative and the police headquarter and I also met a Senior Manager from this big company, but nobody seam to want to do something. Some people told me ' you know it's a big company, so they know what they are doing' or 'they are here for ever so we can't do nothing'. the noise appear in December so it's something new, and it is still here. So because it's a high pitched noise after 2 days and nights in a row you feel stressed, anxious, the noise make you crazy even with ear plugs and my windows close I still hear it, it's a health situation and it can also be a safety issue. Since beginning of January it was audible 26 days and 30 nights over a total of 52 days. Even if it's a big company, they have to respect the Noise Ordinance found in Chapter 9-2 of the City of Austin Codes and Ordinances, and the police or any employee of Austin city should do everything they could to enforce this ordinance. - Not present.
