## HISTORIC LANDMARK COMMISSION Application for a Certificate of Appropriateness April 5, 2023 HR-2022-178783; C14H-1983-0007 Townsend-Thompson Building 718 Congress Avenue

## PROPOSAL

Repair windows and doors, replace glazing, and construct a skylight atop a ca. 1875 landmarked building.

## **PROJECT SPECIFICATIONS**

- 1) Repair existing windows and doors, replacing existing glazing with insulated glazing, adding privacy film to rear glazing only, and painting all to match. Replace existing non-historic door hardware with new bronze hardware.
- 2) Rebuild existing skylight. Steel structure, paint exterior white gloss, with clear anodized aluminum glazing frames and 1" insulated low-E glazing.
- 3) Replace TPO roof in-kind.

## ARCHITECTURE

The 1983 application for historic designation describes the building as follows:

718 Congress Avenue is early Victorian in architecture, with three stone arche s in the second story front. These arches are surmounted by carved rosettes, and in early photographs of the buildings the cast-iron cornice can be seen with a globe atop its center arch.<sup>1</sup>

## **DESIGN STANDARDS**

The City of Austin's <u>Historic Design Standards</u> (March 2021) are based on the Secretary of the Interior's Standards for Rehabilitation and are used to evaluate projects at historic landmarks. The following standards apply to the proposed project:

## Repair and alterations

## 1. General Standards

The proposed project removes and replaces only window glazing, repairing historic-age sashes and molding where extant and possible.

#### 3. Roofs

The proposed project replaces roof material in-kind with TPO, which will not be visible beyond the parapet.

## 5. Windows, Doors, and Screens

See 1. The proposed project applies solar film to alley-facing windows, which will be replaced in-kind. The proposed project does not modify window or door openings.

## Commercial Additions

1. Location

The proposed skylight addition appears to be located at the center of the building, set back from the front wall and utilizing the existing opening.

2. Scale, Massing, and Height See 1.

4. Roofs See 1.

#### <u>Summary</u>

The project meets most of the applicable standards. Staff concurs with Commissioners' assessment of second-floor windows as replacements possibly dating to the era of restoration and historic zoning.


#### **STAFF RECOMMENDATION**

## LOCATION MAP






