

## **M/WBE Summary**

Participation subgoals stated in the solicitation were 1.13% African American; 5.59% Hispanic; 0.89% Asian/Native American; and 3.51% WBE. The recommended firm provided an MBE/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department. The alternate firm provided an MBE/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department.

Public notice was given for this solicitation CLMA036A Brackenridge Gas Insulated Switchgear Substation Reissue, through the City's Austin Finance Online web portal. Three firms submitted qualifications statements and submittals were opened on December 1, 2022. Of the three submittals received, none of the firms submitting were certified MBE/WBE. Of the three firms evaluated, Jingoli Power, LLC was determined to be the best value:
