










### Fuel Mitigation






## 6) The number of training hours received and conducted in the past six months.

### Mitigation and Recovery Efforts -


AFD led a joint-effort with City of Austin Public Works, Austin Resource Recovery, Austin Energy, Austin Parks and Recreation Department, and Texas A&M Forest Service in identifying hazards associated with downed trees and limbs. AFD populated a GIS application with photos, locations, and descriptions of material on roads, power lines, rights of way, sidewalks, and driveways.

In first 48 Hours...

- 98% road network assessment
- 1,400 debris points collected & assigned
- 85% (145) "High Priority" threats mitigated
