Posting Language

Authorize execution of a contract for spoils disposal with AGH2O Holdings LLC, for a term of five years in an amount not to exceed \$4,875,000.

Fiscal Note

Funding in the amount of \$406,250 is available in the Fiscal Year 2022-2023 Operating Budget of Austin Water. Funding for the remaining contract term is contingent upon available funding in future budgets.

Purchasing Language:

The Financial Services Department issued an Invitation for Bids (IFB) 2200 SLW1077 for these services. The solicitation was issued on December 19, 2022, and closed on January 10, 2023. Of the two offers received, the recommended contractor submitted the lowest responsive offer. Council Committee, Boards and Commission Action:

April 19, 2023 - Recommended by the Water and Wastewater Commission on a 7-0 vote with three absences and one vacancy.

Additional Backup Information:

The contract will provide spoils disposal services for the pipeline operations and maintenance units and the construction and rehabilitation unit. The contractor will provide the pickup and disposal of spoils material generated by the maintenance and installation of underground wet utility lines. The generated spoils material

includes debris such as flexible base, hot mix asphaltic concrete, concrete, asphalt millings, soils, clay pipe, vegetation, rock, and other debris generated from street repair and maintenance activities. The City may also take spoils to the contractor's disposal site as needed. The spoils materials will be disposed of in accordance with all Federal, State, and Local regulations.

The current contract expires on August 10, 2023. The requested authorization amount was determined using historical spend with estimated projections. The recommended contractor is the current provider for these services.
