Infrastructure Projects	<ul> <li>WCD staff devoted many hours in February to clearing ice-felled limbs and trees from critical roads, trails, and fences after Winter Storm Mara. Much work remains to clear debris from fences after the avian breeding season concludes.</li> <li>Austin Energy completed extensive vegetation clearing along powerlines plus extensive vegetation removal along access roads in response to the recent ice storm damage, all within the Bull creek macrosite.</li> <li>LCRA: contractors repaired damage (deep ruts) on Kent Butler from their contractors recent work. Work was completed by March 6.</li> <li>Ten Infrastructure Habitat Assessment Applications were processed, and Determination Letters were issued from October 2022 through March 2023.</li> </ul>	
Land Acquisition /Management Agreements	<ul> <li>AW BCP was approached in April 2022 by developer representatives of the proposed Juniper Apartments on FM 620 near Zimmerman Lane adjacent to existing AW BCP-managed Bull Creek Preserves. Because of the proximity of Jollyville salamander springs nearby on Bull Creek, the creek channels making up the proposed preserve, the frequent observation of endangered Golden-cheeked Warblers, the high frequency of nearby caves with endangered karst species, AW BCP offered to manage a small preserve here. A site inspection of Aug 25 revealed several potential filled caves within a block of several federal permit caves. In August, Parks &amp; Recreation requested the site for a public trail through parkland dedication of the development review process and AW BCP has offered to comanage it as a preserve with public trails.</li> <li>AW BCP is working with the owner of Four Points Preserve to transfer ownership to the City. This site is a high priority acquisition, containing 4 BCCP permit caves and springs with Jollyville salamanders.</li> <li>Brodie Oaks Mall representatives drafted an access easement for the portion of Airmen's Cave beneath the mall as requested. It is currently awaiting signature by Brodie Oaks representatives.</li> </ul>	
Reports and Events	<ul> <li>Submitted annual BCCP report to USFWS 2022 Annual Report (traviscountytx.gov)</li> <li>Gave presentations and led field trips for the HCP Coalition Conference (October 25-27), which was held in Austin this year.</li> <li>Austin Water (AW) BCP, Wildlands Conservation staff, Austin Fire Department, and local neighborhood Firewise coordinators toured Bright Leaf Preserve on March 24 to examine wildfire risk elements and get feedback for its management.</li> <li>Hosted a volunteer appreciation event to summarize the first MycoBlitz on the BCP (September 24-October 2) to learn about the role of mycorrhizal communities (symbiotic with plant roots) in habitat restoration and land and natural resources management.</li> <li>A Whirlpool Patio Ribbon Cutting Event was held at the Violet Crown Trail/Whirlpool Cave Preserve at Mopac South and Convict Hill Rd. Councilwoman Paige Ellis and other were guest speakers. A permanent cave mural, cave educational signs, and a salamander sculpture were unveiled. Professionals provided information on bats,tawny crazy ants, UT Grotto,including live bats. A tour of Whirlpool Cave was offered to 118 explorers. The event was sponsored by Public Works, Hill Country Conservancy, and Austin Water Balcones Canyonlands Preserve.</li> </ul>	
Dual- managed Properties	<ul> <li>Mountain-bikers continue to create new, unauthorized trails within the Barton Creek Wilderness and Greenbelt. BCP staff continue to work with Austin Parks &amp; Recreation Dept. (PARD) staff to close them down.</li> <li>Coordinating with PARD on issues related to homeless camps.</li> </ul>

Golden- cheeked Warbler (GCWA) and Black-capped Vireo (BCVI)	Initiated BCVI and GCWA surveys and color-banding in March. Conducted a volunteer training to search for banded GCWAs outside the study plots. Seventy volunteers signed up to assist with search efforts this year.	
Bracted Twistflower	U.S. Fish and Wildlife Service published a final rule to list the Bracted Twistflower as endangered with critical habitat on April 11, 2023 (88 FR 21844).	
Jollyville Plateau Salamander	<ul> <li>BCP continues to conduct aquatic life surveys of springs across the BCP on a periodic basis in hopes of locating new salamander locations and other rare stygobitic life.</li> <li>BCP staff conducted the twice yearly JP salamander survey in Testudo Tube, all salamanders captured were photographed for future population analysis.</li> <li>eDNA: staff assisted TXDOT by allowing their consultant Stantec consulting staff to collect water samples from the Franklin tract at a long term JPS monitoring site (main branch just upstream of tributary 7). TXDOT is taking water samples springs impacted by new road work projects, this method has proven successful in determining JPS presence without actual observations.</li> </ul>	
Karst invertebrates/ karst work	<ul> <li>AW BCP conducted cave faunal surveys and cave cricket exit counts on all other assigned caves (ongoing).</li> <li>In regards to USFWS's five year status review of the 7 listed karst invertebrates in Travis and Williamson Counties, staff provided comments on the current status and documented threats negatively impacting these species.</li> <li>Collaboration Cave (located on the BCNWR): final day of excavation work was completed in March, now efforts will focus on bringing in more rock to improve habitat and periodic species monitoring, since it's likely we will request that this cave be utilized as a substitution for nearby private caves (Jack's Joint and Armadillo Ranch Sink) which we can not access since they are on private property.</li> <li>Currently hydrogeological studies continue in the FM 2222 and RM 620 area. Contractors and staff continue to excavate filled caves on AW BCP preserves along FM 2222 and RM 620 with funding provided from Texas Department of Transportation to mitigate the FM 2222 bypass to RM 620.</li> <li>Mapping and faunal surveys of a new cave (Lady Bird Lounge) on Wildflower Center continues</li> </ul>

Habitat	<ul> <li>Staff and volunteers continued working on restoration projects on the JJ&amp;T and Vireo Preserve tracts to promote water infiltration, slope stabilization, soil restoration, and reforestation on degraded sites to promote future habitat for GCWA and BCVI. Planted over 1,000 native trees and shrubs from October-March.</li> <li>With the abundance of shin oak acorns available in the mast year of 2022, staff</li> </ul>	
Restoration	<ul> <li>planted over 8,000 acorns on Cortaña, JJ&amp;T, Lime Creek, and Vireo Preserve tracts to initiate new BCVI habitat patches and augment existing habitat.</li> <li>Staff used downed juniper limbs from Winter Storm Mara to block and prevent erosion from an unauthorized road carved by a contractor through a stream bed.</li> <li>Scheduled 7 weeks with American Youthworks to restore habitat remove invasive plants, and clean up after Winter Storm Mara.</li> </ul>	
Fencing	<ul> <li>Contractor completed approximately 3000' of fence installation plus a new access gate on a portion of the 3M tract.</li> <li>In preparation for new fence installation projects, BCP staff completed prep work including finding property monuments and determining contractor access for Bright Leaf. Contractor installed approximately 3,300' of fencing on the Bright Leaf boundaries.</li> <li>Kent Butler at Jancy/ Amelia Cv: met on site with 3 adjacent homeowners to discuss options for helping secure our boundaries, following a neighbor meet and greet open house Sept 28. ### Trespass and Criminal Mischief

- Staff have initiated efforts to curtail illegal mining of minerals from the base of the bluff along PARD's Hough tract and BCP's Hiller and Gibson tracts. Staff also observed new climbing routes on the Hough tract immediately adjacent to BCP's Hiller tract, this activity was reported to Pard Rangers.
- Staff have noted a major upswing on trespass at Forest Ridge and the Hiller tracts; this illegal trespass is coming in from the adjacent PARD Hough tract.
- Staff and neighbors have noted an upswing in illegal activities at the end of Old Lampasas Trail including starting fires, so staff is assisting neighbors in efforts to close this problematic portion of Old Lampasas Trail.
- Kent Butler: staff investigated a stolen vehicle incident, apparently a LCRA
  contractor accidentally left the entry gate open which allowed someone to park a
  stolen vehicle inside the property. Police were called and the vehicle was removed
  and the gate was secured.
- Vandals tore down part of an old corral and damaged vegetation at a relic ranch building on the Cortaña tract. Signs of a recent campfire within the structure were also found. WCD rangers reconstructed the corral and posted a "no trespassing" sign.
- Staff reported via 311 in March a pair of homeless camps still in existence within the Barton Creek Wilderness near Loop 360.
- Bright Leaf: a repeated fence cutter and sign vandal was identified, had warrants issued, and made payment for damages assessed.

Continued patrols of Preserve boundaries.

#### **Outreach/Volunteers**

- Produced 4 short educational videos to help dispel myths about Ashe juniper (<u>Ashe Juniper YouTube</u>).
- HCP Conference Field trip: staff led a field trip at Reicher showcasing GCWA habitat, plus had information on karst and other management activities.
- Assisted volunteers with restoration and re-installation of the kiosk at Bright Leaf.
- VWO Karst Preserve: donated native plants and loaned weed wrenches to Stephanie Simmons for the annual Texas Most Wanted native plant give-away event and invasive plant removal work on (March 18, 2023).
- Whirlpool/ VCT educational kiosks: staff helped with wording and provided photos for on HCC's educational signs which were posted near Whirlpool Cave along the adjacent Violet Crown Trail, much of content is karst related.
- Staff gave away many native plants grown from the Reicher greenhouse to various local organizations tasked with multiple restoration projects.
- On behalf of AW BCP, a simulated cave experience was provided to about 450 6-8<sup>th</sup> grade students at McBee Elementary and Brentwood Elementary by CaveSim on March 10 and March 20
- Mark Sanders gave a brief presentation to 6 Science classes at McNeil High, the focus was on cave fauna and the restoration work we are doing in the courtyard, staff also led in cave tours to approximately 64 students. (Nov 18)
