

RESOLUTION NO.

WHEREAS, Austin Housing Finance Corporation (AHFC) is a public instrumentality of the City of Austin and nonprofit corporation that performs an essential governmental function on behalf and for the benefit of the general public, the City of Austin, and the State of Texas; and

WHEREAS, in performing its essential governmental function, AHFC has created nonprofit corporations as instrumentalities of AHFC to fulfill different roles in providing means to finance and develop decent, safe, and sanitary housing at affordable prices for the residents of the City of Austin; and
