

AUSTIN CITY COUNCIL MINUTES

WORK SESSION MEETING TUESDAY, APRIL 18, 2023

The City Council of Austin, Texas convened in a Work Session Meeting on Tuesday, April 18, 2023, at 301 W. 2nd Street, Austin, TX and via videoconference.

Mayor Watson called the Council Meeting to order at 9:01 a.m.

C. COUNCIL ITEMS OF INTEREST

10. Authorize negotiation and execution of a contract for license plate reader camera systems and services with Insight Public Sector, Inc., for up to five years for a total contract amount not to exceed \$1,090,000. [Note: This procurement was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9C (Minority Owned and Women Owned Business Enterprise Procurement Program). For the services required for this procurement, there were no certified M/WBEs; therefore, no subcontracting goals were established].

B. BRIEFINGS

B2. Briefing on lifeguard recruitment and hiring from the Parks and Recreation Department.

The presentation was made by Director Kimberley McNeely, Parks and Recreation Department.

Direction was given to staff to provide Mayor and Council with information regarding Swim Team programs and providing transportation to Life Gaurds as an incentive.

B. BRIEFINGS CONTINUED

B1. Briefing on the Texas Department of Public Safety collaboration with the Austin Police.

Direction was given to staff to provide the number of Department of Public Safety Officers assisting the Austin Police Department. To provide data analysis on violent crimes, drug related arrests, nonviolent, and warrants. Additionally, provide information broken down by districts and demographics on murder and nonnegligent manslaughter, rape, robbery, aggravated assault cases.

It was suggested APD/DPS partnership briefings go before the Public Safety Committee for further discussion.

A request to schedule an Executive Session to discuss the partnership with the State and discuss the creation of an agreement.
