# APPROVAL OF MINUTES

An amendment to replace Commissioner Norton in the duplicate vote listing of Nilson on Item 6 was accepted without objection on Vice Chair Clinton's motion.

A motion to present the recommendation was made by Commissioner Nilson and seconded by Commissioner Norton.

Commissioner Nilson accepted a friendly amendment made by Vice Chair Clinton to edit the first line of BE IT RESOLVED to include "hire or contract with" but was later withdrawn.

A motion to suspend the rules to allow former Chair Nazor to address the Commission regarding the item was approved on Commission Norton's motion, Commissioner Jarl's second.

The recommendation was approved on Commissioner Nilson's motion, Commissioner Norton's second on a 10-0 vote. Commissioners Bruce, Nemer, and Smagula were absent.

Discussion and possible action to approve a recommendation to Council regarding animal welfare in privately-owned aquariums within the City, based on community input.
 A motion to form a working group to look into the Austin Aquarium was approved on Commissioner Nilson's motion, Commissioner Jarl's second on 9-0 vote. Commissioner Hassen abstained. Commissioners Bruce, Nemer, and Smagula were absent.

A request was made by Vice Chair Clinton to involve the Humane Society of the U.S.; Commissioner Jarl also suggested to include the Animal Legal Defense Fund.

Commissioner Nilson volunteered to Chair the working group. Commissioners Jarl and Norton also volunteered to be included in the working group.

 A motion to suspend the rules to allow the working group to present was approved on Commission Jarl's motion, Commissioner Norton's second on a 7-0 vote. Commissioners Hassen, Herrera, and Nilson abstained. Commissioners Bruce, Nemer, and Smagula were absent.
