ANALYSIS / ADDITIONAL INFORMATION: During the week of January 30, 2023 the Austin area experienced an arctic air outbreak that caused freezing temperatures and significant ice accumulation. The City utilized existing department contracts with disaster debris removal and disaster debris monitoring contractors to support recovery efforts utilizing approximately seventy crews (per day) collecting seven days per week. The City is collecting unprecedented amounts of storm debris from the 2023 winter storm. ARR's Debris Removal Contractors collected over 1 million cubic yards in less than 30 days following mobilization. Based on the latest projections Austin Resource Recovery department projects \$20,485,000 in FEMA-winter storm related expenses. Reimbursement is projected to be 75% of eligible Mara-related expenses, or \$15,363,750. FEMA reimbursements for these expenses will be booked to the General Fund Emergency Reserve when they are ultimately received.
