COMMUNITY ENGAGEMENT EVENTS:

Intergenerational Resource and Activity Center and Programming Exploration Survey: In response to Resolution No. 20221208-059, the Parks and Recreation Department is partnering with Austin Public Health and the Intergenerational Resource and Activity Center Advisory Group to explore aspects of a possible future center serving older adults and young children at Nash Hernandez Building. In addition, PARD and APH are partnering to facilitate community engagement around a possible intergenerational center and programming at four possible locations: Nash Hernandez Building (78702, District 3), Rudy Mendez Recreation Center (78702, District 3), Dittmar Recreation Center (78745, District 2), and George Morales Dove Springs Recreation Center (78745, District 2). A survey is being shared with communities around these locations through flyers and pop-ups near each site. In addition, a virtual community meeting will be held, date to be determined. Millennium Youth Entertainment Complex Community Engagement: Beginning in May, the Parks and Recreation Department in connection with the Austin Rosewood Community Development Corporation and ASM Global (MYEC management) will facilitate engagement with MYEC stakeholders to ensure robust opportunities for participation. As acknowledged in the MYEC Audit Report (August 2020), this





process will help to build trust among the various MYEC stakeholders and aims to reconnect with longtime interested community members and users of the Millennium. Grand Meadow Neighborhood Park Concept Plan: The second community meeting for the Grand Meadow Neighborhood Park Concept Plan will took place in person on May 20th at 8022 Thaxton Road, Austin, TX 78747 at 10:00 a.m. Surrounded by single-family homes, the nearly ten-acre property is currently designated as a wildflower meadow. Arts and Culture on Ann and Roy Butler Hike and Bike Trail: On May 20th, the Trail Conservancy (TTC) hosted a kick-off open house for the Arts and Culture Plan at the Seaholm Intake Facility, 801 West Cesar Chavez Street, from 9-11 a.m. In 2021, City Council authorized the negotiation and execution of an agreement with The Trail Conservancy for the operation, maintenance, and programming of the Ann and Roy Butler Hike and Bike Trail at Town Lake Metropolitan Park. As part of the programming effort, TTC launched the development of an Arts and Culture plan for the Ann and Roy Butler Hike and Bike Trail at Town Lake Metropolitan Park. PLANNING UPDATES:

Givens Recreation Center/District Park Multi-use Field Project: The Givens Recreation Center/District Park new restroom, multi-use field, field lighting, and plaza enters the final phase of the project. To date the lighting has been installed and the electrical lines are set to be laid, followed by the adding perimeter of concrete and drainages for the plaza, leveling of the hillside slope, and the installation of turf. The project, supplemented by the General Obligation (GO) Bond, after recent delays is set to be completed late June to early July, with the ribbon cutting set for mid to late July. Mendez Recreation Center Bike Polo Project: Completion of the bike polo court at Metz Park is almost complete as the project closes out phase two. Estimated completion date is early June. This stage includes the development of the project the concrete barrier has since been erected, and the contracts are working on the completions of Americans with Disabilities Act accessible walkways, laying drainage pipes and backfilling around the perimeter from the court to the building. **District 3**



Land Management Program: A draft of the Recommended Land Management Strategies and Climate Vulnerability Analysis, or "PARD land management plan," is nearing completion and will be presented to the Parks and Recreation Board on June 26th and to City Council on July 20th. The Council's Audit and Finance Committee will receive a plan update on May 24th. The land management plan is a technical guiding document for the more than 10,000 acres of natural areas. Implementation of the recommended strategies will maximize community benefits, mitigate risk, and provide ecosystem services, especially those that support human health and well-being, to Austin in perpetuity. This guiding document also prioritizes equity in its recommendations by incorporating measures of social vulnerability as a component of community-level risk. Both environmental and social vulnerability will be used along with many other considerations to create work plans and prioritize their implementation. **All Districts**







The Park Climate Vulnerability Index (CVI) Created Especially for PARD Natural Areas. The CVI Combines Environmental and Social Vulnerability to Estimate the Likelihood of a Negative Climate-driven Event Such as Widespread Canopy Mortality or Intense Wildfire as Well as Residents' Capacity to Prepare for and Recover from Such Events.

Project Connect Update: Community engagement on the five Light Rail Alignment options ended May 2nd. Austin Transit Partnership (ATP) is reviewing staff recommendations and public input, factoring in partner coordination and the Community Advisory Committee. On June 6th, the Tri-Party (COA/CapMetro/ATP) will take action on a final alignment for the Initial Investment. Both Lady Bird Lake crossing options (Statesman / Waller Beach and South First Street / Auditorium shores) will move forward through 30% design, which means the Department will continue evaluating potential parkland impacts and replacement properties for both crossing options. **All Districts** <u>https://www.projectconnect.com/</u>

Texas Legislature Parkland Dedication Bill HB 1526: Two State bills have been proposed as part of the 88th legislative session that would dictate the City of Austin's parkland dedication requirements. Department staff worked with the City of Austin Intergovernmental Relations Office (IGRO) to





communicate the City's concerns regarding these two bills. Specifically, CSHB 1526 requires that cities must designate every area within the city as either suburban, urban or central business district and the appraisal district shall calculate the average land values for each district. Landowners may request a determination from the city of the required dedication amount and, if the city fails to respond within 30 days, the city may not require a parkland dedication or charge a fee-in-lieu of dedication. Changes made to CSHB 1526 narrows the applicability of the statutory parkland dedication regime to only multi-family and hotel-motel uses (Cities can still impose parkland dedication for single-family or two-family uses), creates an Affordable Housing Development Exception, consolidates acquisition and development fee, appears to preserve City's discretion for determining how parkland dedication can be satisfied, and instead of using the formula that accounts for existing parkland levels of service, parkland dedication would be determined and satisfied by the amount of the maximum fee that can be imposed under the bill. https://www.austintexas.gov/PLD_All Districts

Parkland Dedication Conversations: In September 2022, Council approved an updated Parkland Dedication Ordinance (20220915-053) and directed PARD to conduct a stakeholder engagement process to explore and make recommendations on:

- New methodologies for calculating parkland dedication fees for both residential and commercial properties;
- Alternative timing for the City to collect any required fee-in-lieu;
- Potential exemptions for commercial development that produce less than one functional population;
- Revisiting parkland dedication requirements for mixed-use developments; and
- Consider any Planning Commission recommendations not already adopted by Council.

The stakeholder process took place between January 24th and March 14th. The Department and consultants gathered valuable feedback and are working on a draft report that is anticipated to be completed in June.

DEVELOPMENT UPDATES:

Asian American Resource Center (AARC) Phase 2 Improvements: On May 18th, the Department received Council authorization to negotiate and execute an amendment to the design services agreement with Trahan Architects. The Schematic Design phase for the Performing Arts Center and associated improvements as outlined in the 2019 Plan approved by City Council was completed this past November. The project team confirmed that the available funding will not be sufficient to cover the full cost of the Performing Arts Center and associated site improvements that are needed to support the rapidly growing community. The 2018 Bond funds were intended to cover the cost of a 9,500-square-foot facility. The design now consists of a 28,000-square-foot facility and many other outside factors have driven costs up exponentially since 2018. The project will now be split into two phases, 2A and 2B. Design of both phases will continue through Design Development, at which point the project will be divided into one portion to be constructed now (Phase 2A) and the other (Phase 2B) later. Once City Council authorizes the increase of the professional design services contract, the project team will continue to evaluate costs alongside construction logistics to attain the greatest value. The project design will be informed by pan-Asian culture and architecture and embrace the AARC's mission to support and connect diverse Asian American communities in Austin and beyond by creating a space of

Givens and Colony Park Aquatic Facilities: On May 10th, the Colony Park Aquatic Facility project received approval from the Development Services Department (DSD) for the Site Plan Permit. This significant milestone allows the construction of the project to begin. Completion of the proposed facility is planned for the 2024 pool season. On June 1st, the Department will request City Council to authorize an amendment to increase the contractual authority of Construction-Manager-at-Risk for Flintco, LLC, for both Colony Park and Givens pool projects from the original authority of \$14,000,000 to \$20,631,000. Plans for both facilities include a lap lane pool, zero-entry activity pool, water slide, spray ground feature, diving board, gender-neutral bathhouse, family restrooms, training/party room, deck space, and aquatic office space. <u>https://www.austintexas.gov/givenspool</u> **District 1**

Emma S. Barrientos Mexican American Cultural Center: The Joint Venture Miró Rivera Architects + Tatiana Bilbao ESTUDIO (JV MRA+TBE) has completed the Construction Documents for the first package of construction work, which is site and infrastructure. On June 8, the project team will bring two agenda items to Council. The first is for City Council approval to authorize the negotiation and execution of an amendment to JV MRA+TBE's contract to cover additional design through post construction services. DSD is reviewing the revised site development plans to clear the remaining comments and issue the site permit. The second is to authorize an increase in the Construction Cost Limitation with Roger's O'Brien Construction. This increase is required prior to bidding and negotiation of a second package of construction documents, which includes building expansion, renovation, and landscaping. The increased authorization amount will be funded utilizing the additional Parkland Dedication Fees allocated toward the project this past December. Negotiation and execution of a contract with Roger's O'Brien Construction for the first package is in progress. Site construction is anticipated to begin in June 2023. Project completion is anticipated in 2025. Funding is available through the voter-approved 2018 General Obligation Bonds in the amount of \$27,000,000 and \$5,000,000 in Parkland Dedication Fees. https://www.austintexas.gov/MaccPhase2 District 9





Dougherty Arts Center Replacement Project: On May 22nd, the Department will seek a recommendation from the Design Commission for the Dougherty Arts Center (DAC) Replacement project's compliance with the City's Urban Design and Sustainability Guidelines. This presentation serves as a follow-up to the previous Design Commission review in April 2022, in which additional information will be provided about the project's compliance with Subchapter E guidelines and the project budget. The DAC project is approaching completion of the 100% construction document milestone, which is anticipated in July, but moving forward into construction will be contingent on ongoing discussions regarding the project's funding deficit. https://www.austintexas.gov/department/dougherty-arts-center-redevelopment-project_District 9 (previously District 5)




Rendering of the proposed Dougherty Arts Center

Barton Springs Bathhouse Rehabilitation: The Barton Springs Bathhouse Rehabilitation project is currently in the final permitting stages prior to advertising for bidding. The project has passed review by the Design Commission, Austin Historic Landmark Commission, and Texas Historical Commission, and the site plan is currently in the final stages of review. The building permit plans were submitted the week of April 10th for concurrent review with the site plan. Should building and site permits be obtained this month, a request for bids under the Council-approved Competitive Sealed Proposal project delivery method will be advertised in June. The process will take approximately 5-6 months to select, negotiate, and sign contracts with a general contractor. It is currently anticipated that a notice to proceed for construction will be issued in November, at the earliest, upon contract execution. Once started, construction is estimated to take approximately 14 months. Plans and preparations are progressing for temporary facilities for lifeguards, restrooms, and showers. These will be conveniently located next to the bathhouse and be accessible to swimmers throughout construction. Coordination with the Hillside Theater staff for activities during construction regarding traffic patterns, parking, loading, and access to the theater continues to ensure minimal disruption to their activities. The artist for the Art in Public Places component of the project has been selected and is working on the project. Their work will be





installed in the entry portion of the building near the completion of the project. The scope of this project includes structural, accessibility, and utility infrastructure improvements and an overhaul to the Splash! exhibit within the historical bathhouse at Barton Springs Pool. Delays in the project design have come from an expanded scope of work after community engagement indicated a wish to include the Splash! exhibit redesign, additional fundraising needed to meet the revised project cost estimate, coordination of permitting issues in a highly regulated and federally protected natural area, and pandemic-related delays. Project management is headed by the Public Works Department with the Parks and Recreation Department coordinating the Owner requirements. Funding for this rehabilitation project is provided through 2012 and 2018 GO Bond funds, the Historic Preservation Fund, and contributions from the Barton Springs Conservancy. Additional exhibit contributions are provided by the Watershed Protection Department and Austin Water. The Historic Preservation Fund is Hotel Occupancy Tax revenue for projects and initiatives that meet allowable uses as defined under Chapter 351 of the Texas Tax Code and is an essential tool for the promotion of tourism. Public parks, museums, and cultural centers are among the top tourist attractions in the City and the Department works in partnership with the Heritage Tourism Division of the City of Austin Economic Development Department, which manages the Historic Preservation Fund. https://www.austintexas.gov/department/barton-springs-bathhouserehabilitation District 8

Dottie Jordan Neighborhood Park – Recreation Center Restroom Renovation: The Dottie Jordan Recreation Center offers activities for youth, teens, and senior citizens, including Therapeutic Recreation programs for teens and adults with disabilities. A renovation of the building's restrooms has been completed. The project was initiated to correct issues with plumbing and update the facility to current Texas Accessibility Standard requirements. The renovation also included installing an adult-sized changing table within each restroom. The table with an electrical-powered height adjustability system





allows caretakers to have a sanitary space to change an adult or older child with special needs who requires assistance and extra support to fully attend to their personal hygiene needs. Using a changing table allows caregivers to provide toileting assistance at a more level position, rather than bending down and risking back strain or other injuries. The project included reconfiguration of both men's and women's restrooms to accommodate the tables, address wastewater drainage issues, and upgrade utility connections, fixtures, and flooring. The outside sidewalks were replaced to be accessible from the building to the bus stop, as well as the ADA parking area. **District 1**

Mendez Recreation Center (Martin Middle School): Renovation to multipurpose field behind Martin Middle School is underway. Northwest Recreation Center Playground: The new playground equipment has arrived and is currently being installed by the contractor. Estimated time for completion is early summer. **District 7**

Lamar Senior Activity Center Multipurpose Floor: The center experienced a leak in the ceiling of their multipurpose room. The wood flooring will have to be sanded and releveled to remove the warping the water caused. Staff are working with maintenance and a contractor to create a plan to repair the floor when closed in maintenance week. **District 9**





Grey Rock Resurfacing Project: Putting green resurfacing and teeing ground resurfacing work began at Grey Rock Golf Club on May 1st. Around May 28th, a full golf course closure will happen to begin work on the remaining holes. During the closure of the golf course, Grey Rock Tennis, practice facilities, game improvement programs, dining and social programs will continue. In the best interest of the project, the annual July 4th celebration will be cancelled due to staffing and cost concerns. Alternative programming has been provided in the form of discounted monthly dues and food credits. All other Golf ATX properties will be fully open and accessible during this closure and to date, Touchstone has had no members choose to freeze their memberships related to the closure. **District 8**

Technology Update: A new phone queue system has been introduced at Morris Williams Golf Course. The new phone queue is being used for weekend bookings. When customers phone in, the calls are placed in a queue and answered in the order received. This new process has enabled staff to quickly move through weekend bookings. A similar system will be rolling this out to Lions and Clay/Kizer Golf Courses in the near future. **Districts 1, 2 and 10**

Oakwood Cemetery Chapel Monument Installation: The installation of a granite monument at Oakwood Cemetery was completed on May 1st. The monument was designed to memorialize the 36 reinterred men, women and children that were found during archaeology project in 2017, at the time of rehabilitation of the Chapel. **District 1**

South Austin Neighborhood Park – Parking & Exterior ADA Repairs: South Austin Recreation Center, located at South Austin Neighborhood Park, serves as a polling place and cold weather shelter for City of Austin residents. Improvements are underway to provide compliant ADA parking stalls, walkways, a facility entrance, and accessible path from the nearby transit stop. Access from the parking lot to the existing playground will also be renovated to meet compliance. The project is funded by 2018 GO Bonds for ADA Improvements and utilizes the Department Asphalt Parking Lot/Roads Construction, Rehab and Repair IDIQ (Indefinite Delivery, Indefinite Quantity) Contract. Asian American Resource Center – Citizenship Clinic: A citizenship clinic was held on April 22nd, in collaboration with the City's Equity Office, American Gateways, and the National Association of Latino Elected and Appointed Officials (NALEO). This event provided free assistance to community members interested in becoming naturalized U.S. citizens. Attorneys helped participants complete the N400 naturalization application, and a resource fair was held. Representatives from U.S. Citizenship and Immigration Services were present to conduct mock interviews to help attendees prepare for their citizenship interview. The clinic served 61 participants and included 68 volunteers and 24 community tables.



Woodland Health Restoration: Land Management Program staff have been leading and conducting woodland health restoration treatments at the Onion Creek Wildlife Sanctuary. Restoration strategies involve invasive species control, selective thinning, and prescribed burning. In total, 103 acres of restoration treatment will have been conducted by the end of FY23. With additional staffing, this type of work will be scaled up across the natural areas in the Department land management plan.

District 8:

The Austin Nature & Science Center closed out their instructor led programs for the FY2023 school year in April. The Nature's Way preschool also wrapped up the school year for 80 children between the ages of 3 and 6 years old. More than 70 families joined Nature's Way Preschool's end of the year tradition, a picnic in Zilker Park where the students and teachers say goodbye to the school year and hello to summer fun. In addition to the many program participants, the Austin Nature &





Science Center also welcomed 3,047 drop-in visitors to discover the Dino Pit, explore the Naturalist Workshop, splash in the stream, and visit the wildlife exhibits.

Native Bees of Texas Course: The Austin Nature & Science Center hosted the Native Bees of Texas course on May 7th. The program, in partnership with the Jha Lab at the University of Texas provided 20 people with an education in bees that allows them to effectively survey pollinators like a biologist on May 7th.

Barton Spring Pool Operations: Barton Springs pool operates from 5 a.m. to 10 p.m. daily, except for Thursdays when the pool closes between 9 a.m. and 7 p.m. for cleaning. Lifeguards are present between 8 a.m. and 10 p.m. daily. During the Summer, a full shift can see 18-20 lifeguards on site at one time to open all stands. This works out to 30-40 staff working at Barton Springs during the Winter and more than 100 during the summer.

Improvements to the payment systems at Barton Springs Pool have been hampered by a lack of stable and effective internet access in Zilker Park; however, the Department is committed to resolution. Credit cards are accepted via the onsite kiosks and through the ATXSwim app. Cash registers have also returned to provide for cash payment at the payment window. The pool utilizes armored car services to pick up deposits. Security guards are on site to escort guards to their cars after the pool closes. Parking continues to be a challenge for visitors to Barton Springs Pool and Zilker Park.

Prescribed fire licenses and qualifications: The Department and its agency cooperators follow robust federal, state, and city standards for prescribed burning. These standards provide a framework for training and operations as well as establish the legal requirements for burning. In the last year, several Department staff have either begun work toward or completed advanced wildland fire certifications or licenses. The Land Management Program Manager, Matt McCaw, recently obtained the Texas <u>Certified and Insured Prescribed Burn Manager</u> license. Completion of these types of certifications builds knowledge and skills such as operational leadership, technical proficiency, clear communication and delegation, conflict management, high reliability organizing, media relations, risk management, and long-term planning.





ADMINISTRATIVE UPDATES:

Recreation Management System: The Department, with the assistance of the Communications and Technology Management Department (CTM), published a Request for Information (RFI) to survey current technology solutions in the Recreation Management Industry. PARD/CTM received three responses and conducted vendor question and answer sessions and vendor system demonstrations, along with meetings with current user organizations, between September and October 2021. Based on the information gathered, the Department will work with CTM to establish a scope of work (SOW) and conduct a formal solicitation for a future Recreation Management System. As CTM is the principal information technology department that focuses on the delivery and operations of vital IT infrastructure network and telecommunications services for the City, they will facilitate the competitive solicitation process. This includes establishing a CTM project manager and creating a timeline for the solicitation process. In October 2022, the Department began working with a CTM project manager to establish timeline and deliverables for the solicitation scope of work. The Department anticipates the solicitation





process will take over a year to complete. The Department will continue to utilize RecTrac services throughout the solicitation process until a recommended vendor is established.

Watercraft Concession at 2418 Stratford Drive: A Scope of Work (SOW) was developed and presented at the September Parks Board Contracts and Concessions Committee meeting. The solicitation was published on November 9, 2022, and closed January 3, 2023, with four proposals submitted. On March 13, 2023, a recommendation for award to Texas Canoes and Kayaks was posted. The recommendation for the award to the selected vendor was under protest. On May 5th, 2023, Central Procurement cancelled the solicitation on behalf of the City. The contract with the current vendor, Rowing Dock, was extended through October 31, 2023.

Management and Operation of the Pharr Tennis Center: This agreement is for the management and operations of the renovated Burnett "Blondie" Pharr Tennis Center (Pharr). The soon to be renovated facility is anticipated to be completed in August 2023. The Parks Board Contracts and Concessions Committee was briefed at the October 21, 2022, meeting on the solicitation. The solicitation is pending release by Central Procurement. A contract with the successful proposer is anticipated to be executed by the August 2023 renovation completion.

Interlocal Agreement between City of Austin and Austin Community College: This agreement is an interlocal agreement that allows the Austin Community College (ACC) to utilize specified areas of the Turner Roberts Recreation Center to offer consulting and training classes to the public at no charge to participants nor the City. The Interlocal Agreement was approved by Council on March 9, 2023, and is pending approval by ACC on June 6, 2023, for execution. Turner Roberts Recreation Center will begin hosting classes beginning May 30th while pending the contract execution.

Zilker Café: The agreement with the previous vendor has been terminated. A new solicitation is being developed to operate and maintain the food and beverage concession on the north side of Barton Springs Pool in Zilker Park. The solicitation is anticipated to be released in May 2023.

Swim ATX: This agreement is an interlocal agreement with the Austin Independent School District (AISD) for SwimATX, a year-long swim lesson program that includes the 36-hour lifeguard certification course, which will be provided to the students of select AISD high schools.

FY 2024 Budget Development: The Department has submitted its FY 2024 Financial Forecast, and preparation of the Proposed Budget is underway. Below are the City of Austin Budget Calendar key dates:

PARD's Operating Budget Status as of April 30, 2023: Of the \$119 million General Fund budget, 49.5 percent or \$58.9M has been obligated as of the end of April as compared to \$52.8M spent in the same period of the prior fiscal year. \$6.6M of the \$14.1M budgeted General Fund revenue has been collected as of the end of April.

Golf revenue equaling \$6.8M has been collected as of the end of April, which is up compared to the \$5.8M revenue collected by April 2022. Of the \$9.2 million Golf expenditure budget, 58 percent or \$5.4M has been obligated. This is \$843K higher in spending as of April of the prior fiscal year.


2018 General Obligation Bond Program Proposition C – Parks and Recreation (\$149 million) Update: Funding from Proposition C has contributed to over 90 projects and 30 parkland acquisition efforts throughout the City of Austin. The Department has spent \$56.2 million of the \$149 million authorized and has a further \$22.9 million under contract. Recent highlights in the program include:

- Parkland Acquisitions
 - The Department acquired 5.42 acres along Country Club Creek that will function as a neighborhood park, trailhead, and trail connection. <u>The property</u> will provide right-of-way access to the Greenbelt from Douglas and Benjamin Streets. **District 3**
 - The Department acquired <u>a property</u> on 304 Cedarbrook Ct to allow for the construction of Northern Walnut Creek Hike and Bike Trail Phase 2B. The property is located wholly in the floodplain. The installation of trail facilities would further adversely impact the property, necessitating the acquisition to mitigate those impacts. **District 7**
 - City Council approved the purchase of a 3.24 acre property at 901 Ruby Drive. The acquisition will function as a neighborhood park, providing park service to an estimated 2,500 residents currently in a park-deficient area. District 1
- Completed Projects
 - The Department opened the renovated playground at <u>Dottie Jordan Neighborhood Park</u> in April. The playground provides new inclusive, accessible equipment and surfacing to serve the community and align with the Rec Center's therapeutic programs. **District 1**
 - The Department's contractor completed asphalt repairs and resurfacing of the entry drive and parking lot at Mary Moore Searight Metro Park in March. **District 5**
- Construction Starts
 - City Council authorized negotiation and execution of the construction contract for <u>Duncan</u> <u>Neighborhood Park</u> on March 23rd. The Department issued a notice to proceed to the contractor for late May. **District 9**
 - The <u>Colony Park</u> Pool project received its site development permit and the Department will issue a notice to proceed to the contractor this month. **District 1**
 - The <u>Givens</u> Pool project is expected to receive its permit soon and a notice to proceed to the contractor will follow shortly thereafter. **District 1**
 - Playgrounds replacements at McBeth Recreation Center (District 8) and Northwest Recreation Center (District 7) began construction. Alamo Pocket Park (District 1) will also begin construction on a replacement project soon.





- Anticipated Completion
 - The <u>Brush Square Rehabilitation Phase I</u> is expected to be complete within the next month. **District 9**
 - The <u>Givens District Park Vision Plan Phase I Implementation</u> is expected to be complete in June 2023. **District 1**
- Projects in Design
 - The Department has entered the design development phase for the <u>Montopolis</u> (District 3) and <u>Beverly S. Sheffield Northwest</u> (District 7) Pool renovation projects. Renderings of the preferred concepts developed through community engagement are available on the project websites.
 - <u>Oertli Neighborhood Park</u> continues to work through the permitting process. Assuming permit release, construction is anticipated to begin in the fall of 2023. **District 1**
 - Permit drawings are in progress for an initial phase of development of <u>Little Walnut Creek</u> <u>Greenbelt</u> **District 1**
 - Following its approval by the Neighborhood Partnering Program Board, the Department is contributing to the design and development of improvements described in the communityinitiated <u>Donde Corre El Agua</u> Plan along East Williamson Creek Greenbelt. **District 2**



Due to heavy construction cost escalation pressure, the Department continues to hold balances in the Building Renovations, Park Improvements, and Infrastructure categories to serve as program contingencies for ongoing work.
