

ORDINANCE NO. 20230518-037

AN ORDINANCE AMENDING CITY CODE SECTION 12-4-64 (*TABLE OF SPEED LIMITS*) TO MODIFY THE SPEED LIMIT ON NORTH LAMAR BOULEVARD.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. City Code Section 12-4-64 (*Table of Speed Limits*) is amended to delete:

Lamar Boulevard (North) from Parmer Lane to Braker Lane (50 MPH)

Lamar Boulevard (North) from 723 feet north of Oak Brook Drive to 407 feet south of Little Oak Drive (Brentwood Christian School) (35 MPH)

Lamar Boulevard (North) from 250 feet north of West Yager Lane to 750 feet north of West Yager Lane (Not Your Ordinary School Charter School) (35 MPH)

PART 2. City Code Section 12-4-64 (*Table of Speed Limits*) is amended to add:

Lamar Boulevard (North) from Parmer Lane to 723 feet north of Oakbrook Drive (45 MPH)

Lamar Boulevard (North) from 723 feet north of Oakbrook Drive to Braker Lane (40 MPH)

Lamar Boulevard (North) from 723 feet north of Oak Brook Drive to 407 feet south of Little Oak Drive (Brentwood Christian School) (30 MPH)

Lamar Boulevard (North) from 250 feet north of West Yager Lane to 750 feet north of West Yager Lane (Not Your Ordinary School Charter School) (30 MPH)

PART 3. The amendments made in this ordinance are based on the results of a traffic engineering investigation, or speed study, referenced in the Memorandum attached as Exhibit "A".


PART 4. The amendments made in this ordinance shall be incorporated in alphabetical order and the existing entries reordered accordingly.



Ms. Borkar-Desai:

I am recommending a change of speed limit as shown below as per traffic speed studies conducted by the department on Loop 275 (Lamar Boulevard) between FM 734 (Parmer Lane) and Braker Lane in Austin.


- From FM 734 (Parmer Lane) at milepoint 1.277 to 723 feet north of Oakbrook Drive at milepoint 2.351 – From 50 to 45 MPH.
- From 723 ft north of Oak Brook Drive at milepoint 2.351 to the intersection with Braker Lane at milepoint 3.133 – From 50 to 40 MPH.
- School Speed Zones:
 - From 750 ft north of Yager Lane at milepoint 1.571 to 250 ft north of Yager Lane at milepoint 1.666 – From 35 to 30 MPH.
 - From 723 ft north of Oak Brook Drive at milepoint 2.351 to 407 ft south of Little Oak Drive at milepoint 2.680 – From 35 to 30 MPH.

The study was conducted as per provisions of the Texas Transportation Code, Chapter 545, Subchapter H “Speed Restrictions” and TxDOT’s “Procedures for Establishing Speed Zones.”

I anticipate prompt approval of the proposed speed limits by the City of Austin.
