Request: Approve a resolution authorizing a redevelopment exception in the Barton Springs Zone under City Code Section 25-8-26 for a tract in the City's extraterritorial jurisdiction.

The project, Texas Research International Expansion, proposes redevelopment of an existing commercial use on a 17.6-acre tract located at 9225 FM 2244. This action concerns land located within the Barton Springs Zone, in the extraterritorial jurisdiction.
