## **DISCUSSION AND ACTION ITEMS**

Site-Specific Save Our Springs (SOS) Amendment. Discuss and consider an ordinance granting a site-specific amendment to City Code Section 25-8-514 (*Pollution Prevention Required*) of the Save Our Springs Initiative, granting a variance to City Code Section 25-8-364 (*Floodplain Modification*) and Section 25-8-641 (*Removal Prohibited*) relating to the removal of a heritage tree, and waiving requirements of City Code Section 25-8-41 (*Land Use Commission Variances*) to allow construction of the Slaughter Lane Improvement Project from Loop 1 (MoPac) to 650 feet east of Brodie Lane, located at 5015 <sup>1</sup>/<sub>2</sub> West Slaughter Lane (C20-2022-019).
