

AUSTIN CITY COUNCIL MINUTES

WORK SESSION MEETING TUESDAY, MAY 30, 2023

The City Council of Austin, Texas convened in a Work Session Meeting on Tuesday, May 30, 2023, at 301 W. 2nd Street, Austin, TX and via Videoconference.

Mayor Watson called the Council Meeting to order at 9:00 a.m. Council Members Harper-Madison and Kelly participated virtually.
