2. North Burnet/Gateway TOD Subdistrict. Discuss and consider a recommendation <u>for adoption</u> of an ordinance amending City Code Title 25 relating to the North Burnet/Gateway Regulating Plan, to modify the Gateway and Midway Zones, within the Transit Oriented Development Subdistrict, to increase the maximum floor-to-area ratio and building height when using a development bonus. Members of the public, David Hartman (Dubois, Bryant, and Campbell) and Nikelle Meade (Husch Blackwell, LLP) addressed the board. Jorge Rousselin (HPD Staff) presented. Following discussion, on Commissioner Anderson's motion, Vice Chair Hempel's second, the recommendation was approved, with the change that the new regulations specified in the Burnet/Gateway Regulating Plan also be applied to the Midway district plan. The motion passed on a 6-0-0 vote with Commissioner Kiolbassa absent.
