



Monthly Report on License Agreement 2023-06 June

This report is in agreement with the terms outlined in Section 8.4 of the License Agreement between the City of Austin and Austin Pets Alive! with a focus on APA!'s impact on Travis county through our partnership with Austin Animal Center.

Summary: Austin Pets Alive! (APA!) continues to be the city of Austin's largest partner in lifesaving. APA! takes animals that have medical and behavioral issues that require a higher cost per animal than the average healthy animal in care. APA! focuses on these animals in an effort to have a measurable effect on the live release rate at AAC.

APA! Intakes transferred from AAC:

349 animals were transferred out of AAC to rescue partners in June. 269, or 77.1%, of those were transferred to APA! *The AAC dashboard indicates 257 transfers to APA!, but there are 12 missing.*

9 animals were born in APA!'s care to pregnant animals sent from AAC. Additionally, APA! took in 74 pets directly from owners within Travis county through the PASS program that should have otherwise entered AAC. This makes for a total of 83 intakes diverted from AAC, a 7.7% intake reduction.

Fiscal Year 2023, Q3 Summary

Austin Animal Center reported 3,345 cat and dog intakes from April-June 2023. 750 animals, or 22.4% of intakes, were transferred to APA! in that time. Of those, 565 (75%) were urgent/immediate transfers with 2-hour deadlines.

APA! directly diverted 336 animals from entering the city shelter system, which equals a 9.1% intake reduction for AAC. This number includes surrender intakes from Travis County via the PASS Program and animals born in APA!'s care to moms transferred from AAC.

All AAC-attributed intakes (transfers and born-in-care to AAC moms) combined to make up 27% of APA!'s overall shelter intake in FYQ3. AAC continues to be the largest sending partner of APA!.
