## Posting Language

Authorize negotiation and execution of a contract for mobile demineralizer rental and water treatment parts with MPW Industrial Services Group Inc., for up to five years for a total contract amount not to exceed \$500,000.

#### Fiscal Note

Funding in the amount of \$16,667 is available in the Fiscal Year 2022-2023 Operating Budget of Austin Energy. Funding for the remaining contract term is contingent upon available funding in future budgets.

The Financial Services Department issued a Request for Proposals (RFP) 1100 JMF3020 for these goods and services. The solicitation was issued on January 30, 2023, and closed on March 2, 2023. The recommended contractor submitted the only responsive offer. ### Additional Backup Information:

The contract will provide mobile water demineralizer rentals and water treatment parts for Austin Energy. Demineralizer equipment is used to treat boiler water at power plants during emergency situations, extreme winter weather events, or when equipment is offline. Power-generating equipment requires specially treated

water to prevent degradation of the equipment or mineral buildup in the equipment.

An evaluation team with expertise in this area evaluated the offers and scored MPW Industrial Services Group Inc. as the best to provide these services based on price, local preference, service-disabled veteran business enterprise, solution, and experience.
