

## **MBE/WBE Summary**

Public notice was given for this solicitation CLMC976 South Tarrytown Water and Wastewater Pipeline Renewal project, through the City's Financial Services website, Austin Finance Online. Five bids were received and opened on May 11, 2023. Of the five bids received, two bids were from MBE/WBE certified firms. Facilities Rehabilitation, Inc. submitted the lowest responsive bid including two allowances in the amount of \$1,008,000:
