## **RESOLUTION NO.**

WHEREAS, the City is eligible for \$14,292,696 in federal grant funds, including Community Development Block Grant (CDBG), Home Investment Partnerships Program (HOME), Housing Opportunities for Persons with AIDS (HOPWA), and Emergency Solutions Grants (ESG) from the United States Department of Housing and Urban Development (HUD) for Fiscal Year (FY) 2023-2024 (collectively, the "Federal HUD Grant"); and

WHEREAS, the City's proposed FY 2023-2024 Community Development Program and annual Action Plan will use the Federal HUD Grant and local funding; and

WHEREAS, the City Council has, in accordance with Texas Local Government Code Section 373.006(1), (2), and (3):

- identified in its FY 2019-2024 Consolidated Plan, adopted on June 6, 2019, areas of the municipality in which predominantly low- and moderate-income persons reside, or that are blighted or slum areas; and
- established in its FY 2019-2024 Consolidated Plan, adopted on June
  6, 2019, community development program areas in which community development activities, building rehabilitation, or the acquisition of privately owned buildings or land are proposed; and

 adopted a Citizen Participation Plan (CCP) under which residents may publicly comment on proposed community development programs and the annual Action Plan (Resolution No. 960328-31, as amended by Resolution Nos. 000113-29, 040129-8, 20111215-089, and 20200521-014); and

WHEREAS, in accordance with Texas Local Government Code Section 373.006(4) and Part 91, Title 24 of the Code of Federal Regulations, the City Council conducted public hearings, on March 23, 2023, and June 8, 2023, to obtain public comment on the proposed Action Plan; and

WHEREAS, in accordance with Texas Local Government Code Section 373.006(4) and Part 91, Title 24 of the Code of Federal Regulations, the Community Development Commission conducted public hearings on April 11, 2023, and May 9, 2023, to obtain public comment on the proposed Action Plan and made its final recommendation on the proposed Action Plan on June 13, 2023; and

WHEREAS, the City made the proposed Action Plan available for a public comment period beginning on May 9, 2023, and running through June 9, 2023; NOW, THEREFORE,

## BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

The City Council approves the FY 2023-2024 Action Plan and related Funding Table (attached to this resolution and identified as **Exhibit "A"**).

## **BE IT FURTHER RESOLVED:**

The City Council authorizes the City Manager to submit, attest, execute, and deliver the necessary grant applications, certifications, and other related documents, including, but not limited to, applications, a final statement of community development objectives, projected use of funds, and any required certifications, and to negotiate, as necessary, with HUD for the Federal HUD Grant.
