

NOTICE OF PUBLIC HEARING TO AMEND AUSTIN'S LAND DEVELOPMENT CODE

This notice is to inform you that the City of Austin is holding public hearings to consider proposed amendments to the City of Austin's Land Development Code.

Proposed Amendment:

Site specific amendments to SOS (Save our Springs) Ordinance as necessary for the Barton Springs Bath House capital improvements. This site is in the Barton Springs Zone.

The proposed amendments will be considered during public hearings before the Planning Commission and the City Council. At these hearings, you will have an opportunity to speak FOR or AGAINST the proposed code amendments by appearing in-person or by participating remotely (by telephone). During its public hearing, the Planning Commission makes its recommendation on the proposed amendments to City Council. At City Council's public hearing, the City Council may adopt amendments recommended by City staff, the Planning Commission, or both. Additionally, City Council may make its additional changes to the proposed amendments.

If the Planning Commission or City Council announce a specific date and time for postponement or continuation, no additional notice will be sent. Contact the Case Manager listed below for further information on how to participate in the public hearings.
