A motion to recommend the Austin-Bergstrom International Airport (AUS) update to the 2012 Master Development Plan (MDP) ordinance with conditions was made by Commissioner Bristol and seconded by Commissioner Ramberg.

A substitute motion, proposed by Commissioner Brimer, to approve the ordinance without variances F-O, as noted in the AUS Ordinance backup, and expedite public hearing requests from Aviation Department to the Environmental Commission, to the extent possible, failed when it was not seconded. Commissioner Einhorn was absent.

An amendment by Commissioner Ramberg, seconded by Commissioner Sullivan, to request an annual report to the Environmental Commission on projects from the past year, Water quality monitoring updates, and community engagement updates, was added on a 10-0 vote. Commissioner Einhorn was absent.

7. Name: Little Bear Creek Recharge Enhancement Project SOS Amendment C20-2023-0009 Applicant: City of Austin – Watershed Protection Department (Scott E. Hiers, P.G.) Location: 16002 Oak Arbor Trail, Buda, Texas 78610

Request: In response to Council Resolution 20230420-026, consider variances and amendments to the Land Development Code, including site-specific amendments to Chapter 25-8, Subchapter A, Article 13 (Save Our Springs Initiative), as necessary to allow for the completion of the Little Bear Aquifer Recharge Enhancement Project, an aquifer recharge project at Stoneledge Quarry within the Barton Springs Segment of the Edwards Aquifer. The project will increase the amount of clean water entering the Aquifer, thereby increasing water storage in the Aquifer, enhancing flows at Barton Springs and the Colorado River, and supporting the aquatic and terrestrial species dependent on this water.
