Hello Nancy,

Thank you for your call today -

To review, the Austin Fire Department has requested an engineering report addressing concerns they might have about industrial uses that might be near or adjacent to this site on Industrial Blvd.

We have solicited bids for this study, selected a vendor, and signed their proposal.  
Now we wait.

I anticipate a month for this engineering firm to conduct the study and submit a report to the Austin Fire Department, and about an equal amount of time for city staff at AFD to review the submittal and report favorably to you and your team in Planning & Zoning.

Assuming we postpone 60 days at the August 8th Planning Commission, we could still likely overshoot a 60-day postponement by a week, maybe two. Statute only allows for 60 days.

With your consent, we would like to ask for an indefinite postponement next week, while communicating clearly that we will be on the agenda by early or mid-November.  
I will appear before The Commission on August 8th to lay this out and to request a little more patience from the Commission on this project.  
Please place the item for Discussion Postponement.
