TERM: The Agreement commences upon August 19, 2021 at 12:01am and ends on September 30, 20243 at 11:59pm (the "Term") LICENSEE UNDERSTANDS AND AGREES THAT THIS LICENSE IS REVOCABLE AND AGENCY MAY ON ANY DATE AND AT ANY TIME BEFORE SEPTEMBER 30, 20243, TERMINATE THIS LICENSE AGREEMENT IN ITS SOLE DISCRETION WITH OR WITHOUT CAUSE AND LICENSEE SHALL VACATE PREMISES WITHIN THE TIME PRESCRIBED IN SECTION 7.B.ii. LICENSEE UNDERSTANDS AND AGREES THAT THE AGENCY AND ITS CONSULTANTS MAY ACCESS THE PROPERTY AT ANY TIME FOR PURPOSES OF PREPARING FOR THE REDEVELOPMENT OF THE SITE AND THAT SUCH ACCESS WILL BE COORDINATED WITH THE LICENSOR AND ITS CONSULTANTS TO MINIMIZE DISRUPTION TO BUSINESS OPERATIONS.
