

TEMPO ON THE TRAIL

The intent for TEMPO is to promote tourism, cultivate curiosity, spark imagination, engage the community in a meaningful dialogue about public art, foster work by local artists and cultivate exploration of the City of Austin. Artists are encouraged to create artworks that reflect the site where they exhibit their work, and design artwork that can be easily installed and de-installed.

The Ann and Roy Butler Hike-and-Bike Trail at Lady Bird Lake courses through the heart of Austin. With more than 4.9 million visits a year, the 10-mile trail is Austin's most recognized and popular recreational area.

How did we get here?

CONCURRENT DISTINCT PROCESSES



AIPP contributed \$10,000 to TTC's **Art + Culture** planning process to specifically focus on engagement and public art visioning. (2-year process)

Results = Art + Culture Plan and Collection Management Policy for TTC that:

- outlines processes of managing autonomous site activations and Temporary Installations/Exhibitions
- 2. confirms that TTC will follow established AIPP processes for loans, donations and permanent artwork commissions



August 3, 2021

AIPP hosted interviews and focus group conversations about the TEMPO program (AIPP Panel, AIPP Senior staff, and past TEMPO artists)

GOAL

Program assessment = made recommendations that led to redesigning the TEMPO program to accommodate a flexible and nimble practice that also defies current limitations, breaks down institutional rigidity and goes beyond expectations to meet artists where they are while maximizing community impact



What is the Collections Management Policy?

Developed under provision of the City of Austin Artwork Donation and Loan Policy and Application (Adopted 3-21-13, revised 12/2014 and 11/2018) that allows a City department to borrow or acquire artwork without obtaining Arts Commission approval, if it has an adopted and approved Collection Management Policy in place: Section VI- 2.

TEMPO ON THE TRAIL


One-year pilot program

- Supports TTC launch of a substantial program within the framework of AIPP's established process
- 2. Support through partnership while AIPP program rebuilds capacities and restructures processes
- 3. Meets some strategic goals recommended during AIPP program assessment

FUNDING

\$225,000 Cultural Arts Division to TTC 8 artists x \$25,000 stipend 10 -12 month exhibition period

How will artists be selected?

Call For Artists drafted by TTC guided by goals
Step 1: from community engagement reviewed by A + C
Committee

Step 2: Artists Selection Panel – A + C Committee

Step 3: Artists' Applications Review/Approval - A + C Committee

Step 4: Contracts - Selected artists will receive \$25,000 stipend for design, fabrication and installation

Step 5: **Technical Review:** AIPP & PARD's Community Activated Parks Program (CAPP) process


