# HISTORIC LANDMARK COMMISSION DEMOLITION AND RELOCATION PERMITS SEPTEMBER 6, 2023 PR-2023-048490; GF-2023-087257 908 JOSEPHINE STREET

## PROPOSAL

Demolish a ca. 1941 house.

#### ARCHITECTURE

One-story rock veneer house with a multilight casement beneath a fanlight, paired with an arched front door; cross-gabled roofline with "catslide" roof at front gable leading to an arched gateway; arched vents at gable ends; and 1:1 wood windows.

### RESEARCH

The house at 908 Josephine Street was built in 1941 for Ben and Jimmie Garza. Ben Garza, who served in the Army during World War II, later worked as an insurance agent and then a supervisor for Kocurek Service Station and Auto Supply. 908 Josephine was also home to Jimmie Garza's sister, Grace, and her brother-in-law, Patrick, while Ben and Patrick were both serving in the Army. Jimmie Garza's mother also lived there during the 1960s. The Garzas owned 908 Josephine until at least the mid-1970s.

### **PROPERTY EVALUATION**

## Designation Criteria—Historic Landmark

- 1) The building is more than 50 years old.
- 2) The building appears to retain high integrity.
- 3) Properties must meet two criteria for landmark designation (LDC §25-2-352). Staff has evaluated the property and determined that does not meet two criteria:
  - *a*. Architecture. The building is a good example of a styled Minimal Traditional house with "storybook" Tudor Revival details. Its archways, whimsical catslide roof with arched garden gate, and rock veneer are emblematic of a once-popular stylistic variation in Austin, rapidly disappearing.
  - b. Historical association. The property does not appear to have significant historical associations.
  - *c*. Archaeology. The property was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
  - *d*. Community value. The property was not evaluated for its ability to possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
  - *e*. Landscape feature. The property does not appear to be a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

## **STAFF RECOMMENDATION**

Strongly encourage rehabilitation and adaptive reuse, then relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package.




