- The CSBG Act states the purpose is "to provide assistance to States and local communities, working through a network of community action agencies and other neighborhood-based organizations, for the reduction of poverty, the revitalization of low-income communities, and the empowerment of low-income families and individuals in rural and urban areas to become fully self-sufficient"





Case Management Services

Self Sufficiency Case Management

Assistance to help clients achieve and maintain incomes above 125% of the FPIL (Federal Poverty Income Limits) for at least 90 days.

Includes:

- Assessment and Service Plan
- Employment Support-Job search assistance, Job readiness, Job Retention
- > Linkage to education and training, other social services
- Housing (rent assistance) & transportation (bus passes)
- Crisis intervention & short-term counseling
- Budgeting and financial counseling
 - Services provided by licensed social workers.

- Persons obtaining an educational or vocational degree or certificate.


