Authorize an amendment to a contract for the Existing Terminal Centralized Baggage Handling System Upgrades Project with the Whiting-Turner Contracting Company, to increase the amount by \$83,808,109 for a total revised contract amount not to exceed \$256,863,723.

# Additional Backup Information:

The project is for a new centralized baggage handling system (BHS) that will improve airport flow of baggage and passengers, support the Transportation Security Administration's (TSA) efficiency, and future growth of the airport. This contract allows Department of Aviation staff to work with a highly qualified design and

construction team to explore design alternatives, costs, locations, construction schedule of a long-term reconfiguration and replacement of the BHS included in the 2040 AUS Masterplan and future operational requirements.

This request for additional authorization will complete the cost of construction to expand the original BHS to the West Infill, its associated terminal volume space design, and construction to accommodate increasing airport flight operations, passenger security screening volumes, and needed airline support space.

The BHS West Infill expansion now includes a total of approximately 75,000 square feet which includes the baggage, concourse Check Point 3 expansion, apron, and mezzanine-level spaces. The baggage level space will expand the current design to add 25,000 square feet to provide future BHS growth and TSA support space. The concourse level will add approximately six to eight new security checkpoint-screening lanes which will reduce passenger lines during peak travel periods. The apron level expansion will provide additional airline office and support facilities and outbound baggage handling processing space. The mezzanine level expansion of 20,000 square feet will provide the airport with the ability to provide a revenue-generating passenger lounge and airline office and training spaces. The additional authorization will allow for the completion of all design and construction associated costs for an estimated BHS project completion in March 2026.

If the proposed amendment is not approved, the new centralized BHS will not meet the increasing security screening, terminal operations, and passenger processing needs of the airport.
