## **QUESTIONS FROM COUNCIL**

**Item #1:** Authorize the issuance of rebates for multifamily and commercial customer energy efficiency measures by Austin Energy during Fiscal Year 2023-2024 in the aggregate amounts of \$2,900,000 for multifamily programs and \$3,600,000 for commercial programs, for a total combined budget amount of \$6,500,000.

**Item #18:** Approve a resolution adopting the Austin Convention and Visitors Bureau d/b/a Visit Austin 2023-2024 Marketing Plan and Proposed Budget of \$28,016,012; setting the contract payment as required by Chapter 351 of the Texas Tax Code; and authorizing the City Manager to file approved documents with the City Clerk's Office as required by the Texas Tax Code. COUNCIL MEMBER FUENTES' OFFICE

1) How does this budget differ from or work with the TPID?

The Visit Austin budget before City Council on October 21, 2023 is the baseline funding for Visit Austin that comes from hotel occupancy tax (HOT) funded by the Tourism & Promotion Fund and the Austin Convention Center Department as well as private funding. The funds stewarded by Visit Austin support sales and marketing efforts focused on maintaining and growing HOT to support Cultural Arts, Historic Preservation, expansion of the Convention Center and the local hotel industry. These funds also support the day-to-day operations of Visit Austin. The funding from the Austin Tourism Public Improvement District (ATPID) is supplemental funding that Visit Austin will use to enhance sales and marketing efforts to further grow the HOT collection, revenues, and overall tourism in the City. In short, the TPID will amplify Visit Austin's current marketing plan, and provide enhanced funding to accomplish efforts Visit Austin would not otherwise be able to afford.

**Item #18:** Approve a resolution adopting the Austin Convention and Visitors Bureau d/b/a Visit Austin 2023-2024 Marketing Plan and Proposed Budget of \$28,016,012; setting the contract payment as required by Chapter 351 of the Texas Tax Code; and authorizing the City Manager to file approved documents with the City Clerk's Office as required by the Texas Tax Code. COUNCIL MEMBER A. ALTER OFFICE

1) What if any investments in marketing or promotion of the 2024 Total Eclipse does Visit Austin intend to make in FY23-24? If the 2024 Total Eclipse is not currently part of Visit Austin's planning for FY23-24, what steps could Visit Austin take to incorporate this opportunity into their work? Are any other departments doing any planning around the needs of the 2024 Total Eclipse?

Visit Austin has included the 2024 Eclipse in its marketing plan (page 14). Planned activities include, but are not limited to, social media, dedicated landing page, media outreach / pitching, travel planner trainings and printed collateral, including branded solar eclipse viewing glasses. Please see the attached presentation detailing these efforts.

**Item #24:** Authorize negotiation and execution of a contract for an event booking software system with UB Holdings, LLC d/b/a Ungerboeck Systems International, LLC and Momentus Technologies, for a term of five years in an amount not to exceed \$1,400,000. COUNCIL MEMBER A. ALTER'S OFFICE

1) Please provide additional context for why this contract is limited to the Convention Center and the Austin Public Library. Were any other departments considered for this contract, including but not limited to PARD? If not, please explain why. If other departments were considered, please explain why this item was limited to just these two departments.

The Austin Convention Center and Austin Public Library have utilized this contractor's event booking software since June 2015. The contract includes provisions allowing other City departments to purchase this software if they choose to change their event booking software in the future. In this case, staff may need to return to Council for additional expenditure authority.

**Item #28:** Authorize execution of a contract for traffic paint and thermoplastic marking materials with Ennis-Flint Inc., for five years for a total amount not to exceed \$3,250,000. COUNCIL MEMBER FUENTES' OFFICE

1) Is the traffic paint and associated materials environmentally sustainable? Is it reflective and does it allow heat to bounce off?

The traffic paint being purchased is a waterborne product that generally has lower volatile organic compound (VOC) levels than solvent-based paints. Lower VOC levels are generally more environmentally sustainable.

The paint and markings are reflective, and generally lighter colored paint on the ground has been found to have lower temperatures than asphalt in the same area.

**Item #32:** Authorize execution of a contract for the 2020 Bond Traffic and Pedestrian Signals -Installation and Maintenance project with EAR Telecommunications, LLC, for up to three and a half years for a total contract amount not to exceed \$5,000,000. COUNCIL MEMBER FUENTES' OFFICE

**Item #37:** Authorize an amendment to a contract for preconstruction, schematic design, and construction services for the Canyon Creek Fire Station with JE Dunn Construction Inc., to increase the amount by \$20,000,000 for a revised total contract amount not to exceed \$91,550,000. COUNCIL MEBER A. ALTER'S OFFICE

 Please provide additional information on the anticipated timing for the funding and construction of the APD substation mentioned in the back-up for this item. The earliest opportunity for the construction funding request would be for FY 24-25. Construction start would begin thereafter.

**Item #49:** Authorize negotiation and execution of a contract for an electronic citation and crash software system including maintenance and support services with Tyler Technologies Inc., for up to three years for a total contract amount not to exceed \$800,000. COUNCIL MEMBER A. ALTER'S OFFICE

1) Is this a new system being adopted or is this item intended to continue a system we already have in use?

Tyler Technologies Inc. owns Austin Police Department's current e-ticket/e-crash system, Brazos. The contract will continue the use of the existing Brazos system.

**Item #55:** Approve an ordinance relating to a joint public hearing between the City Council and the Planning Commission for certain changes to City Code Chapter 25-2 (Zoning), establishing the notice requirements for the joint public hearing, and waiving City Code Sections 25-1-501 (Initiation of Amendment) and 25-1-502 (Amendment and Review). COUNCIL MEMBER A. ALTER'S OFFICE

1) When will the referenced exhibit containing the actual proposed notification requirements be available?

The document has been updated and is available online.

**Item #59:** Approve a resolution approving the appointment of members of the police reserve force. COUNCIL MEMBER A. ALTER'S OFFICE

1) In the Q:A for the prior vote on this item the staff response to one of our questions included the following:

It is APD's plan for Reserve Officers to only work Special Events and only at barricade or traffic control assignments. Reserve Officers shall not respond to calls for service; however, Reserve Officers shall take enforcement action to preserve the peace and protect life/property. The Special Event Coordinator will place a Reserve Officer with a full-time APD Officer at traffic control assignments requiring more than one officer to control the intersection, if staffing allows. Reserve Officers shall not hold or work secondary employment contracts requiring the use of law enforcement powers under the APD commission or work elective departmental overtime.

Is this still the plan for these Reserve Officers?

Yes, this is the plan

**Item #63:** Authorize negotiation and execution of eight agreements with six social service agencies to provide basic needs services for 60-months beginning October 1, 2023, in an amount not to exceed \$1,808,601, divided among the six agencies. COUNCIL MEMBER FUENTES' OFFICE

- 1) Does the living wage apply in these social service contracts? No.
- 2) Considering the possible contract extension up to 60 months, does this agreement account for the cost-of-living adjustment for the following years?

No it does not. Budget amendments can be made to adjust budget line items to fit the spending needs of the agency. An annual increase to the Austin Public Health social services budget would be required to account for the cost-of-living adjustments for following years.

**Item #80:** Conduct a public hearing and consider an ordinance authorizing the negotiation and execution of an economic development agreement with NXP USA, Inc., under the City of Austin Chapter 380 Economic Development Policy.

COUNCIL MEMBER FUENTES' OFFICE

1) City policy and contract language imply that the City living wage will apply to all NXP employees, including current employees. Is this the intent of the contract?

Yes. One of the minimum requirements of the City's <u>Chapter 380 Program</u> is that compensation for all Austin-based employees is no less than the City's living wage, which may be adjusted annually at the discretion of City Council. In addition to paying a living wage to all full-time and contract employees, the requirement to pay at least the greater of the U.S. DOL prevailing wage or City's living wage is applicable to construction workers for all general contractors and subcontractors working on the site.

Sections 1.1.04, 1.1.06, and 1.2.04 of the draft award agreement combine to require that employees in all current and newly created direct jobs, and construction workers employed in Austin are paid at least at the current City living wage. In the event the living wage increases by more than the consumer price index in any year, the agreement allows the company up to 180 calendar days to increase wages to the newly implemented living wage.

2) There is a health insurance provision in the contract that provides in-house benefits or stipend equivalent to full-time employees, though the dollar value is not stated. What is the dollar value of the benefit and stipend? Does this cover most/all of the individual employee's insurance? Yes. One of the minimum requirements of the City's Chapter 380 Program is that compensation for all Austin-based employees is no less than the City's living wage, which may be adjusted annually at the discretion of City Council. In addition to paying a living wage to all full-time and contract employees, the requirement to pay at least the greater of the U.S. DOL prevailing wage or City's living wage is applicable to construction workers for all general contractors and subcontractors working on the site.

Sections 1.1.04, 1.1.06, and 1.2.04 of the <u>draft award agreement</u> combine to require that employees in all current and newly created direct jobs, and construction workers employed in Austin are paid at least at the current City living wage. In the event the living wage increases by more than the consumer price index in any year, the agreement allows the company up to 180 calendar days to increase wages to the newly implemented living wage.

3) The contract states that 42 of the 53 new hires will live in Austin. Does this mean that the company will hire individuals who are established local residents (living in the area prior to beginning of hiring) rather than individuals from outside the area who can then later establish residency?

In order to qualify as a New Full-time Job under this agreement, the new employee must be a permanent resident of the 5-county (Bastrop, Caldwell, Hays, Travis, Williamson) MSA, which encompasses the five-county metropolitan area surrounding Austin. Anticipated creation of 53 jobs detailed in section 1.2.01 of the <u>draft award agreement</u> reflects the estimated job creation represented in the project application. The obligated creation of 42 jobs in section 1.2.02 of the <u>draft award agreement</u> is the minimum job creation attainment to maintain compliance with the agreement. The later level of job creation represents the minimum job creation level after accommodating for a 20% variance to remain in compliance. Job creation reflected in both provisions of the <u>draft award agreement</u> represent they be filled with local residents.

4) The contract specifies a career ladder for at least 40% of the project's Austin-based employees. How was this percentage determined?

Section 1.3.01 of the <u>draft award agreement</u> details company requirements for Talent Development. The career ladder component of the Talent Development requirement is based on the company's responses in the <u>Project application</u> and compliance standards subsequently agreed to through negotiation of the <u>draft award agreement</u>. The 40% commitment was determined to be the threshold for a company's career ladder to qualify as a community benefit, and for the company to receive points on the scoring matrix. The 40% constitutes acceptable community benefit, and 60% qualifies as an exceptional community benefit.

Section 2 of the <u>Project's Scoring Matrix</u> details the points achieved through review of the <u>Project application</u> and additional information found in the Company's Sustainability reports for <u>2021</u> and <u>2022</u>.

5) When you combine City of Austin and potential federal Chips Act funding, the company would receive about \$15,565,332 in taxpayer dollars for creating 53 new jobs, at a cost of \$293,685 per job created. Is there a way to increase the number of new jobs?

Among the aims of the federal CHIPS funding are facilitation of American semiconductor production, and strengthening the supply chain. The <u>Project application</u>'s dynamics (including job creation, capital investment and commitment to community benefits) are the sole discretion of the applicant. City staff must assume that the Company's financial proforma for the expansion balances the project's financial viability after factoring in the cost of capital improvements and ongoing expenses related to additional job creation.

A large portion of the capital investment would replace fully depreciated equipment, which in some cases is likely to be fully decommissioned and removed entirely from the tax roll. This

investment will allow the Company to shift production to meet current market demand for semiconductor wafers. As a result, the Project effectively provides a firmer foundation in retaining existing 2,700 jobs.

The proposed Project's fiscal benefit to area local governments is largely achieved through the replacement of antiquated product lines, with a capital investment of just under \$300.0 million. The City's incentive is based on the new investment only, which is projected to result in an estimated net fiscal benefit to the City of approximately \$1.6 million over the five year period.

The proposed City of Austin award would be roughly a 2.5% to 7% match to an estimated Chips award. By comparison typical EDA Economic Assistance grants and state Enterprise Fund awards require a minimum 20% and 15% local match, respectively. 6) A question was raised during work session about enforcement of the contract. The answer was that there is a margin of 20% where the company can fall short of its targets but still get 100% of the incentives. Is this correct?

The <u>Project application</u>'s dynamics (including job creation, capital investment and commitment to community benefits) are the sole discretion of the applicant. **Item #103:** Conduct a public hearing and consider an ordinance adopting the Palm District Plan as an element of the Imagine Austin Comprehensive Plan. COUNCIL MEMBER FUENTES' OFFICE

1) How will city staff engage stakeholders in implementation of the Plan?

As directed by the resolution, staff will work to identify an implementation governance structure for the Palm District

Plan that will build on existing governance entities currently overseeing work in the district. As an initial next step, Downtown Austin Alliance will convene an implementation governance working group to bring together key stakeholders referenced in the companion resolution to explore options for implementation governance. In addition to any Plan implementation governance structure, stakeholders would also be engaged in various ways in each of the major initiatives that are moving forward in the district (including design of Waterloo Greenway, design of Convention Center reconstruction, IH 35 Cap and Stitch development, etc).

2) What is the status of the Rainey Street Development Fund that was previously established? This <u>memo</u> was provided to Council in November of 2022. Additional information is below:

\$1,091,789 is available for the 64 Rainey Street Project. Please see below the anticipated timeline for the projects outlined in the memo - it starts with the vacation of right of way and the attached document details the estimated project costs.

PARD and TPW recently negotiated the vacation of right of way and the required property survey identify the alleyway adjacent to 64 Rainey Street has been complete. PARD is currently filing the application to vacate of the alleyway. Below is the *estimated* project timeline:

**SEPT 2023** Completed tasks include vetting of the vacation of the alley with City Departments; research for interpretive panels on history of the community; selection of Project Manager; donation of park furniture by Canvus; approval of AIPP for mural installation by Raul Valdez (recreating the mural that was destroyed at the Lincoln Juarez University.) OCT 2023 Installation of Canvus furniture and resurfacing of 64 Rainey Street for temporary usage. DEC 2023 TENTATIVE- Council action on the vacation of the alley adjacent to 64 Rainey Street. Interpretive panel text is completed. A/E work in adjacent alley is underway. JAN 2024 Selection of Landscape Architect from rotation list to begin. Graphic design for historic Interpretive panels to begin. A/E work continues. MAR 2024 Design process for Rainey Street Project and Gran Entrada to begin. Interpretive panels in production. SEPT 2024 Conclusion of A/E projects in Alley. Commencement of construction of 64 Rainey Street project. MAY 2025 Installation of Raul Valdez Mural AUG 2025 Installation of historic Interpretive Panels and Gran Entrada SEPT 2025 Tentative date for opening of ESB-MACC and 64 Rainey Street Project.


The pocket park project is now expected to be completed Summer 2025 to align with the completion of the MACC Phase II construction project completion. It is important to note, the MACC project is on a schedule delay and therefore aligning the work outlined in the memo with the MACC construction schedule has also delayed the pocket park project completion date. The completion date for both projects is Summer 2025.

The ESB-MACC project (<u>https://www.austintexas.gov/MaccPhase2</u>) schedule is planned as follows:

• Construction Documentation/Permitting/Bidding: Began January 2023

- Site Construction Start: August/September 2023
- AE Chilled Water Construction Start: October 2023
- Construction Substantial completion: Anticipated Spring 2025
- Grand Opening: Anticipated Summer 2025
- 3) Can you share the JPA with the Waller Creek Conservancy? The Waller Creek Local Government Corporation is governed by a set of bylaws. The Waterloo Greenway Conservancy and Waller Creek LGC work in the district under the parameters of a Joint Development Agreement.
- 4) Our understanding is that there were sections of the Plan that were recommendations from East Austin and Mexican-American Stakeholders that were not included in the report. Are those public and where can we find them?

As part of the engagement process, the City contracted with Martha Cotera to conduct targeted engagement activities with East Austin thought leaders and community members with historic ties to the district and Palm School. The 2024 eclipse will be a total eclipse. During a total eclipse, the moon completely blocks the sun. Even though the sun is about 400 times larger than the moon, the distance between each solar body creates the illusion that they're the same size in the sky when viewed from earth.

#### When Will the Eclipse Be Visible in Austin?


