PROPOSAL

Demolish a ca. 1947 house. No new construction is proposed.

ARCHITECTURE

One-story masonry veneer house with multi-light metal casement windows and attached carport.

RESEARCH

The house at 4210 Wilshire Parkway was built in 1947. Its first occupants, Reginald and Dorothy Shinn, lived in the home until around 1953; Reginald Shinn was in the Air Force. Its next residents, the Wilsons, only lived in the home for a few years before selling it to the McGuires, another Air Force family.

PROPERTY EVALUATION

The property contributes to the Wilshire Wood National Register district.


Designation Criteria—Historic Landmark

- 1) The building is more than 50 years old.
- 2) The building appears to retain high integrity.
- 3) Properties must meet two criteria for landmark designation (LDC §25-2-352). Staff has evaluated the property and determined that it does not meet two criteria:
 - a. Architecture. The building does not appear to convey architectural significance.
 - b. Historical association. The property does not appear to have significant historical associations.
 - c. Archaeology. The property was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
 - d. Community value. The property does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
 - e. Landscape feature. The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

STAFF RECOMMENDATION

Encourage adaptive reuse and rehabilitation, then relocation over demolition, but release the demolition permit upon completion of a City of Austin Documentation Package.
