

## CARLOS LEÓN


This letter documents continuing and escalating abusive harassment/stalking behavior by an older bald White Male, who appears homeless, about 5'7" and 200 pounds, and approximately between 50 and 59 years of age, allegedly called "Ed", against me - Carlos León, a Straight Christian Male. There is no personal or professional history between me and him. He recently initiated, continued, and escalated his satanic harassment/stalking behavior against me AFTER repeatedly observing me attend a weekly Men's Bible Study in the earliest AM at Rudy's BBQ at 3914 N Lamar Blvd, Austin, TX 78756.

First, he'd sicko stare at me while I was participating in that Men's Bible Study. I ignored him, staying focused on reading and discussing God's word with fellow brothers in Christ. Second, a few weeks ago, after Bible Study had finished, I was sitting at the most southeast table in the middle room and he was sitting at the most northeast table in the middle room. I was peacefully and silently working on my laptop, when he started yelling at me, "Hey!" I silently ignored him to not follow his mislead to not allow him to distract me from my work to not allow him to refocus my attention from my laptop screen onto him to not give him the attention he was seeking from me. So he yelled, "Hey!" a second time. I silently ignored him a second time for the same reasons as the first.

He then held up a pen in his hand and yelled something like, "Is this your pen?!" Though he would likely claim he was only trying to be "helpful," do not be fooled. He was yelling something like, "Is this your pen?!" to try hurting me by again trying to make me follow his mislead to distract me from my work to refocus my attention from my laptop screen onto him to give him the attention he was seeking from me. So I silently ignored him a third time for the same reasons as the first two times. He seemed angry and annoyed I wouldn't follow his mislead to not allow him to distract me from my work to not allow him to refocus my attention from my laptop screen onto him to not give him the attention he was seeking from me.

Normal, healthy people do not act like he did. Normal, healthy people do not concern themselves with a cheap pen they see on a table in a BBQ joint. Normal, healthy people do not bother trying to return a cheap pen they find on a table in a BBQ joint to a fellow customer who they think it belongs. Normal, healthy people do not repeatedly yell at a fellow customer who they think the pen belongs. Normal, healthy people simply leave the pen alone or give it to an employee, at most. Therefore, he was using the found pen as pretext to try initiating a power imbalance interaction with me to control what he believed to be my property, and me. He was also trying to make me believe I had "lost" or "left" a pen to make me believe I had made a mistake that he was correcting, to make me doubt myself/feel stupid and him look good, to treat me like his child and him act like my parent. That's how sick, evil, abusive sex offenders think and behave against their targets. F-CK that. Therefore, I kept ignoring him until he stopped yelling at me and went on his way.

Third, last week [9/15/23], after the Bible Study group finished, I purchased a small coffee, like always. When I returned to my table in the middle room, one table from older bald regular/daily earliest AM White Male customer who's about 5'7" and 200 pounds, I saw him sitting at his table, trying to stare me down, eye-to-eye, with an intense look on his face. He clearly was trying to



psychologically bully me, trying to make me look down or away from his stare. Another words, he was trying to intimidate me.

Therefore, I defeated his psychological and spiritual attack by NOT looking away or down; sitting down at my table, facing him, I looked right back at him, eye-to-eye, without saying a word. He seemed angry I returned his stare right back at him.

Consequently, he then intensely asked me, "Do you have a problem?", while still trying to stare me down. He was trying to make me answer his unnecessary, uninvited, unwelcome question to follow his mislead to make me accommodate and serve him to confuse and control me to effeminate and emasculate me to gaslight and dominate me to mistreat me like a battered/abused bitch. In fact, he seemed to have a problem, meaning he was trying to project his problem on to me to try making me take responsibility for his problem — a standard psych warfare tactic abusers use against their targets to try exerting power, control, and dominance over them. Therefore, I defeated his psychological attack by not answering, responding to, or acknowledging his question; I simply continued returning his stare right back at him, without saying a word.

He didn't like that either, so he seriously repeated his "Do you have a problem?" question, as if saying it a second time would somehow indicate increased importance and force me to respond how he wanted, like that female attorney played by Demi Moore in "A Few Good Men" who strenuously objects after the judge overrules her objection https://www.youtube.com/watch?v=bOnRHAyXqYY. F-CK THAT. I simply continued looking right back at him without saying a word for a couple more seconds before taking out my laptop and doing some computer work then and there, which I almost always do after Bible Study. Though I was focused on my laptop screen then, I continued facing him to monitor his physical movements in front of me. Though he did not approach me, he did go back and forth, in and out of his seat, leaving his backpack/gear behind on his table, which I left alone. When I exited Rudy's about 10 minutes later, he was sitting outside on Rudy's picnic bench. He didn't say anything to me and I didn't say anything to him. I went on my way; he did not follow.

I rightly filed a written complaint that same day with Rudy's BBQ against him, documenting his sicko, aggressive, abusive stalking behavior to justify me telling Rudy's BBQ to warn him to stop harassing me or to ban him from the eatery. However, Rudy's wrongly responded by rewarding him and punishing me, the targeted individual, telling me only on 9/22/23 I was no longer welcome at that Rudy's BBQ. Rudy's BBQ protecting him only emboldened him.

Fourth, yesterday afternoon [9/23/23], I went to Austin Public Library – Central location, the huge six-story building at Seaholm, to do some laptop work in the 4th Floor Reading Room, an enclosed, quiet space I had NOT previously used. I neither told anyone ahead of time where I was going nor told anyone where I was when I was there. Yet, when I was leaving that room, he was just sitting in the adjacent Special Collections room by himself, not reading or doing anything. As soon as he saw me leaving the Reading Room, he immediately got up and quickly walked away from me, like a guilty little boy, jamming himself into a nearby full passenger elevator with his back to me, trying to avoid being detected. Too late. Before the elevator doors closed, I told him [to his back], "DO NOT STALK ME!"

I took the next elevator down to 2<sup>nd</sup> floor APL Security to report that stalking incident, the previous Rudy's BBQ incidents documented in this report, and tell Security where and when to look for him on their cameras to visually ID him and prepare that video to be turned over to APD. After that, when I was walking outside Austin Public Library — Central toward the Seaholm eastbound bus stop on Cesar

Chavez, I saw him watching me from across the street with his buddies. I then looked at him and yelled at him to stop stalking me. He told me to go fuck myself. I told him he was on video and to expect APD to deal with him. I then continued on to my bus stop to wait for, then catch my bus.

Therefore, since you can usually find him almost every morning at Rudy's BBQ at 3914 N Lamar Blvd between 6 AM and 7 AM at the most northeast table in the middle room or sitting at Rudi's outside picnic table [sometimes smoking a cigarette], tell him in person to stop stalking and harassing me, and to expect to be cited/arrested if he continues doing so because stalking violates Texas Penal Code § 42.072 (a)(3)(d). Because Rudy's BBQ at 3914 N Lamar Blvd told me I am no longer welcome there, I do not go there anymore.
