Regulated Trees in Austin

Levels of Tree Ordinance Protection




8" and larger

- Survey required on commercial site plan submittals



19" and larger are Protected Trees

- All species are protected
- Tree permit required for removal or impacts (residential and public)



24" and larger may be Heritage Trees

- Only specific species qualify
- Variance required for removal or impacts that exceed code requirements
- Variances can be administrative
- Greater penalties for unpermitted impacts

30" and larger Heritage Trees

- Proposed variances must go through public process



Regulated Trees in Austin

- Includes hackberry, cedar, invasives, hazardous trees, etc.
- Certain species are designated as Heritage Trees when they reach 24" diameter (LDC 25-8-602)
- Palm trees are not regulated under the COA tree ordinance.

 - . Step 1: Identify regulated trees on your property.
 - . Step 2: Determine whether a building permit is required.
 - . Step 3: Apply for your permit(s).
 - . Optional: How to schedule an on-site Pre-plan Submittal Consultation

- . How long it takes –The Planning and Development Review Department shall take action on an application to remove a protected tree: not later than the 10th working day after the complete application is filed.
- . Forms/processes required? Austin Build + Connect (AB+C)

Who to Contact if You Suspect Un-permitted Removal?

- . From City Arborist webpage Report a Tree Violation Look for a Permit
- . Use the <u>Public Search</u> tool in the Austin Build + Connect (AB+C) Portal to see if a permit has been issued for the work you're seeing.
- . Under Search by Property, enter the street address where the work is taking place. Click Submit.
- In the search results, you will be able to click on the Permit/Case Number to view details of the permit.
- . If no permits are listed in the public database, you may have witnessed a violation of City tree regulations.




Who to Contact if You Suspect Un-permitted Removal? – Cont.

- To report a Tree Violation Contact 311 <u>Request a City Service</u> tool to report a suspected tree violation online. For Service Type, select "DSD -Environmental Complaint" from the dropdown menu.
- You can also download the <u>Austin 3-1-1 mobile app</u> or call <u>3-1-1</u> or <u>512-</u>
 <u>974-2000</u> (outside city limits) and speak to a representative.
- . All complaints (service requests) city wide are tracked through CSR 311 ! Very similar to AFD and APD.
- The Environmental Inspections Division is in the process of obtaining approval for responding to after-hours 311 tree complaints. This would include having inspectors on-call from 3:30 pm – 8:00 pm. Monday thru Friday and Saturday 7:30am-5:00pm. The after-hours schedule will align with what is already approved and in place for CODE Enforcement's after hours and weekend enforcement teams.
