Hispanic/Latino Quality of Life Resource Advisory Commission

The Board/Commission mission statement (per the City Code) is:

§ 2-1-146 - HISPANIC/LATINO QUALITY OF LIFE RESOURCE ADVISORY COMMISSION.

- (A) The Hispanic/Latino Quality of Life Resource Advisory Commission should have a balanced membership reflecting in-depth knowledge of the challenges and concerns of the Hispanic/Latino community. The City Council should appoint persons who are representative of or sensitive to the needs of the Hispanic/Latino community in the City of Austin.
- (B) The commission shall advise the City Council on issues relating to the quality of life for the City's Hispanic/Latino community and shall recommend programs and policies designed to alleviate any inequities that may confront Hispanics and Latinos in social, economic, and vocational pursuits including education, youth services, housing and community development, cultural arts, economic development, health, civic engagement, and transportation.
- 1. Describe the board's actions supporting their mission during the previous calendar year. Address all elements of the board's mission statement as provided in the relevant sections of the City Code.

The Commission received staff and community briefings and provided feedback to various departments on issues. This year included the following presentations:

Members of the Commission provided representation in regular meetings regarding the Joint Inclusion Committee (JIC). Chair Amanda Afifi participated in the regularly scheduled JIC meetings. Vice Chair Sharon Vigil was the JIC alternate until April 25, 2023, when Vice Chair Ivanna Neri became the new JIC alternate.

Chair Afifi, Vice-Chair Vigil, and Commissioners Peña, Silva, and Perales represented the Commission in the group Quality of Life Commission / Equity Budgeting Sessions and meetings. With the support of the Equity Office the JIC conducted three virtual town hall sessions organized around the identified priority issues to receive input from community members regarding funding needs for the 2023-24 Budget. These Quality of Life town hall sessions included invited representatives from the ten commissions that make up the JIC. Commissioners attended all three budget townhalls. Commissioners provided feedback regarding the evolving budget process. This process also allowed for us to contribute to joint recommendations made.

In March 2023, the Commission made the following FY2024 budget recommendations, related to the issue areas in the H/LQoL Initiative:

The motion to approve the FY23-24 Budget Recommendation for Community Health Workers was approved on Commissioner Daniela Silva's motion, Commissioner Ivanna Neri's second on a 7 – 0 vote. (Off the Dais/Absent: Commissioners Maria Solis, Sandy Ramirez, & Sharon Vigil).
- Recommendation 20230328-007: FY23-24 Budget Recommendation on Affordable
 Transportation. The motion to approve the FY23-24 Budget Recommendation for Transit
 & Transportation was approved on Commissioner Jesus Perales's motion, Commissioner
 Vanessa Maldonado's second on a 7 0 vote. (Off the Dais/Absent: Commissioners
 Maria Solis, Sandy Ramirez, & Sharon Vigil).
- Recommendation 20230328-008: FY23-24 Budget Recommendation on Enhanced Library Card Program. The motion to approve the FY23-24 Budget Recommendation for the Austin Public Library Municipal ID Card with an amendment that asks APD to accept this Municipal ID as a form of identification, and that includes additional funding for outreach in multiple languages to reach underrepresented communities about this service was approved on Commissioner Ivanna Neri's motion, Commissioner Daniela Silva's second on a 7 0 vote. (Off the Dais/Absent: Commissioners Maria Solis, Sandy Ramirez, & Sharon Vigil).
- Recommendation 20230328-010: FY23-24 Budget Recommendation on Guaranteed Income Program. The motion to approve the FY23-24 Budget Recommendation for the Guaranteed Income Program with an amendment that stipulates new participants in the program would be screened for eligibility by the same criteria as participants from the original pilot was approved on Commissioner Daniela Silva's motion, Commissioner Ivanna Neri's second on a 6 1 0 vote. (Abstain: Ivanna Neri. Off the Dais/Absent: Commissioners Maria Solis, Sandy Ramirez, & Sharon Vigil).
- Recommendation 20230328-012: FY23-24 Budget Recommendation on Immigrant Legal Services. The motion to approve the FY23-24 Budget Recommendation for Immigrant Legal Services was approved on Commissioner Amanda Afifi's motion, Commissioner

- Recommendation 20230328-013: FY23-24 Budget Recommendation on Supporting Youth & Children in Austin. The motion to approve the FY23-24 Budget Recommendation for Supporting Children & Youth in Austin with an amendment to merge item 14 and item 13 into one budget recommendation that includes a specified allocation of \$550,000 for Academia Cuauhtli's expanded Aztech Coding program for Indigenous, Latinx/Hispanic and Black youth in East Austin was approved on Commissioner Dulce Castañeda's motion, Commissioner Daniela Silva's second on a 7 0 vote. (Off the Dais/Absent: Commissioners Maria Solis, Sandy Ramirez, & Sharon Vigil).

- 1. Ensure recommendations and decisions have equitable outcomes for all members of the Hispanic/Latino community;
- 2. Co-create more equitable policies, developed alongside fellow Quality of Life Commissions and the Joint Inclusion Committee;
- 3. Ensure community members have various opportunities to provide direct input to the Commission regarding budget needs, as well as host a budget centered meeting after submitting recommendations to inform the community of finalized recommendations and next steps in the process;
- 4. Expand awareness of Quality of Life Commission to inform the community about the Commission:
- 5. Closely collaborate with City staff regarding recommendations and concerns in the community;
- 6. commit to promote language and digital access (visual and auditory; multiple languages; easily understandable reading comprehension level);
- 7. Obtain funding for a new Quality of Life Study, and coordinate with appropriate stakeholders to develop a continuing process to update information on a more frequent basis:
- 8. Identify a goal(s) for each working group and implement a plan to address the goal(s); and
- Continue to collaborate with agencies, non-profits, service providers, the City of Austin, the faith community and others to eliminate the disparities and increase the number of preventive measures in the Hispanic/Latino community.
