



PARKS AND RECREATION BOARD DIRECTOR'S REPORT

COMMUNITY ENGAGEMENT EVENTS:

Grand Meadow Neighborhood Park Concept Plan: The final community meeting for the Grand Meadow Neighborhood Park Concept Plan will take place virtually on Tuesday, September 26th at 6:30 p.m. Surrounded by single-family homes, the nearly ten-acre park is currently designated as a wildflower meadow. Shaped by community feedback, the Austin Parks Foundation, in coordination with the Parks and Recreation Department (Department), has developed a concept plan to guide the future development of Grand Meadow Neighborhood Park. PLANNING UPDATES:

Montopolis School: City Council approved an ordinance authorizing the dedication of 500 Montopolis Drive as parkland at its September 21st meeting. The Montopolis School property (.852 acres) and the adjacent property (.428 acres), currently the site of the St. Edwards Baptist Church, were previously purchased by the City. **District 3**

Brodie Oaks PUD: The Brodie Oaks shopping center redevelopment is a proposed Planned Unit Development (PUD) located at Loop 360 and South Lamar, at the site of the former Brodie Oaks shopping center. A third reading was rescheduled from the Council Meeting on August 31st to September 21st. Council approved the zoning on first reading on December 8, 2022 (Item 96). A second hearing was approved on May 18, 2022 (Item 55). Council approved the zoning on the third and final reading September 21, 2023. The PUD includes dedicating 11.6 acres of new parkland, expanding the Barton Creek Greenbelt. The Parks and Recreation Board voted unanimously to recommend the PUD as superior at the September 26, 2022 meeting. **District 5**

Givens Recreation Center: The project for the new Restroom, Multi-Use Field to include Lighting, and a Plaza replacement south of Givens Recreation Center is almost complete. The project includes a larger fully accessible restroom adjacent to a new plaza with shaded picnic seating and an accessible walkway that will connect to the recreation center. The project also replaces the under-utilized ballfield with a multi-purpose field, including new fencing and field lighting. Last month the final improvements included the installation of sod, with the remaining items to include the finalization of gas and plumbing lines for the plaza and a final walk through scheduled for the end of this month. The site will host a ribbon cutting celebration in correlation of National night out on October 3rd. DEVELOPMENT UPDATES:

Dougherty Arts Center Replacement Project: On September 26th, the Dougherty Arts Center Replacement project will be seeking approval of a conditional use site plan from the Planning Commission. This is typically the final step in achieving a site development permit for the project, prior to proceeding with bidding and construction. As designed, the new Dougherty Arts Center is an approximately 50,000 sf facility that will continue its mission of supporting arts access for all in a healthy, sustainable, and resilient environment through its five primary programmatic components: the Dougherty Theater, Julia C. Butridge Gallery, Artist Professional Development, Arts Outreach, and the Dougherty Arts School. The project has a budget shortfall; however, achieving this final step prior to bidding and construction will allow flexibility in the project schedule as funding challenges continue to be addressed. Barton Springs Bathhouse Rehabilitation: Barton Springs Bathhouse Rehabilitation: A final hearing for the SOS Amendment was rescheduled from the September 14th Council meeting to September 21st. An insufficient number of Council members were present at the September 14th meeting for a vote to grant supermajority approval, which is required for an SOS amendment to pass. The site-specific amendment was considered by City Council and approved on September 21st. The SOS Ordinance amendment allows the rehabilitation of the existing building on the south side of William Barton Drive, new underground water and wastewater service to support the bathhouse structure with adequate fire flow, construction of a fire lane on the west side of the bathhouse for adequate emergency access around the structure, and landscaping around the restroom building and on the south side of William Barton Drive to improve the quality of existing vegetation. The Competitive Sealed Proposal solicitation for construction was posted on June 26th and proposals were due on August 31st. Two proposals were received and are under evaluation. Construction is anticipated to start in early 2024. Funding for the rehabilitation project is provided through 2012 GO Bond funds, the Historic Preservation Fund, and contributions from the Barton Springs Conservancy. Additional exhibit contributions are provided by the city's Watershed Protection Department and Austin Water Department. **District 8**

Sir Swante Palm Neighborhood Park Renovation: After two Open House events at the end of August to kick off the Community Engagement phase for the redesign of Palm Park, additional opportunities for the public to provide feedback will continue through the end of the year. An <u>online survey</u> is now live to provide community members who were not able to attend the August meetings an opportunity to give their input. Tarrytown Neighborhood Park Playground Renovation: The renovation is tentatively scheduled for completion on October 15th with the re-opening of the playground expected the following week.





Improvements include expanding the curb to increase play opportunities, new traditional playground equipment at both the 2-5-year-old and the 5-12-year-old play areas with integrated shade, new ADA-compliant sidewalks, a new drinking fountain with a dog bowl feature, stand-alone xylophone and cabasa music elements, and new seating amenities. **District 10**

MAINTENANCE UPDATES:

Dottie Jordan Neighborhood Park: The nature play project at Dottie Jordan playground has been completed. The project included installing a stump table to improve the overall seating and a multiple log balance area. The nature play structures assist in filling in the open spaces on the playground and add a unique nature component. Annual Maintenance Week: Mendez Recreation Center recently completed the facilities annual maintenance week. Improvements and repairs to the site included, repainting of the men's and women's restrooms, and repair of the sliding door in the facilities arts and crafts room. **District 3**

Security Lighting: Gus Garcia Recreation Center is currently in the process of acquiring additional security lighting for its back area. This will increase visibility and ensure a higher degree of public safety. **District 4**

Cellular Dialer System: Cellular dialer system has been installed in annex building of the South Austin Senior Activity Center. The system will eliminate the numerous false alarm calls due to defective telephone line. Cellular dialer system was also updated in main building. Wires were rerouted to increase safety and streamline future inspections. **District 5**

The Greene Room Renovation at Zilker Botanical Garden: The Greene Room at the Zilker Botanical Garden will be undergoing renovations beginning in early October with preparation work beginning in late September. Construction is expected to be completed by mid-March 2024 with a project cost estimated at \$450,000. **District 8**

District 1:

ATX Music Creative Hub Town Hall: The ATX Music Creative Hub Town Hall for the Asian American Resource Center Music Hub was held on September 9th. The event saw over 60 attendees, including local musicians, producers, artists, community members, and notable figures such as Austin Independent School District (AISD) School Board President Arati Singh and Grammy Award-winning singer Sangeeta Kaur. The discussion was led by representatives from EQ Austin and was centered around what the community wants to see from a potential music hub in the city. Each attendee was given the opportunity to speak during their introductions, and the session concluded with a brief discussion of specific needs in the community. 63 people attended the event.

District 3:

Development Program at Parque Zaragoza Recreation Center: Parque Zaragoza Recreation Center recently began their development program this past September. The new program is incorporated into the Out of School Time program held at the site. The program includes curriculum that teaches money management, encourages volunteer work, while offering them community support projects. The intent of the program is to assist youth as they enter the transition from 6th grade into 7th and 8th grade. The program serves as a bridge program for youths transitioning out of the sites after school program into teen and middle school programs, while teaching them independence. The program currently has eight participants registered and is offered weekdays after-school.

Viva Mexico Celebration: The Emma S. Barrientos Mexican American Cultural Center's **(**ESB MACC**)** 16th annual Viva México celebration occurred at the Oswaldo A.B. Cantu Pan American Recreation Center on Saturday, September 16th from 5-9 p.m. Guests at this free outdoor event enjoyed Mariachi and Ballet Folklorico performances, live Tejano and Country music, and a local youth talent showcase including young musicians from Burnet Middle School. The family-focused event also offered a Community Resource Fair with over 15 City departments and non-profits, a family-friendly kids activity tent, and local food and art vendors. Master of Ceremonies, Claudia Talamantez from Univision and Mexican Consul General Pablo Marentes, lead the public in the annual *Grito de Independencia*. The ESB MACC





has partnered with the Pan Am Recreation Center to offer this event for the first time on the iconic Pan Am Hillside stage, where Austin's Latino community has gathered to enjoy live music and celebrate Tejano/ Chicano/ Latino culture for generations. The event was attended by about 700 people.





Auxiliary Programs for the Pan Am Recreation Center After School Program: September marked the return of auxiliary programs for the Pan Am Recreation center after school program. These programs included the Science, Technology, Engineering and Mathematics (STEM) curriculum through the Police Activities League (PAL) program that educates youth participants on how to build using science and technology. In addition, this program includes the Reading Aces and Dream Outside the Box, two curriculums provided by the University of Texas that engage youth participants through reading education and activities that promote positive youth choices and future development. Each of the three programs is offered on various days in the afternoon during the sites after-school, program, and is available as a supporting curriculum for the 48 participants registered in the out of school program.

Mendez Recreation Center: Mendez Recreation Center will be offering four sessions of tennis play days in the months of the fall at the Multi-Use Court at Metz Park, with one each month from September through December. The program will be open to youths ages 5-12 and will include a registration cost of \$10 per session. The program will be held, Saturday mornings 10 a.m.-12 p.m. on September 9th, October 14th, November 11th, and December 9th. There were 11 attendees at the September 9th event.



Youth Futsal Skills and Drill Program: The Youth Futsal Skills and Drill Program began on Wednesday, September 6th at Mendez Recreation Center. The program is run Wednesday evenings from 5-7 p.m. with two separate age groups at Metz Park. Practice for children 5-8 years of age will run from 5-6 p.m. while children 9-12 years of age will practice from 6-7 p.m. Registration is August 21st-November 29th. Currently, the program has six participants in the 5-8 years of age group and is still accepting registration. There are currently no children 9-12 years of age registered, but registration is still being accepted. Practices are held on the multipurpose court in Metz Park. The program cost is \$10 per participant per month.

Aquatic Seasonal Pools:

- Due to the ongoing heatwave and sufficient lifeguard staffing, six seasonal pools will extend operations until October 1st: Garrison, Northwest, Govalle, Mabel Davis, Shipe, Walnut Creek Pools.
- Fees have been waived through October 1st at Garrison, Northwest, Walnut Creek and Bartholomew Pools. **Districts 3, 4, 5, 7 and 9**

Historic Preservation and Tourism Program Updates: The Department received an Honor Award for the historic Downs Field Grandstands Rehabilitation by Preservation Texas, a statewide nonprofit organization, at an awards luncheon on September 21st. The site was first used in the 1920s by Samuel Huston College baseball and the Austin Black Senators, the first Negro Baseball League team in Austin. Later, the site hosted the original L.C. Anderson's Yellowjackets football team. In 1954, Downs Field was established at the site and named in honor of Reverend Karl Downs (1912-1948), who was President of Samuel Huston College. Today, Downs Field is the home field of the Huston-Tillotson Rams. The project included replacement of the corrugated metal roof and structural upgrades to the steel supports and wood framing, while replicating the original architectural characteristics. The restoration of the grandstands follows a multi-year effort to renovate and enhance the field.

Additionally, Sarah Marshall, the Department Historic Preservation and Tourism Program Coordinator, has been named the chairperson of the *History in Our Parks* advisory committee of the American Association of State and Local History (AASLH), a national organization that provides leadership and resources to make history more meaningful to all people. Sarah was a leader in the development of the History in Our Parks advisory committee, which was formed to address the unique needs and challenges of parks and recreation agencies that care for historic and cultural resources while operating within a





system that is not solely geared towards heritage preservation. She supported early efforts to gather data on the number of parks and recreation agencies that care for historic and cultural resources (such as museums, historic sites, collections, archeological sites, cemeteries, and landscapes), initiate an assessment of their needs and challenges, and explore how AASLH can assist the group. This committee represents members who practice history in a variety of ways in parks programs and in turn, advises the AASLH on the development of programs and services for the group. **District 1, Multiple**

Zilker Shuttle Pilot Program: The Zilker Park Weekend Shuttle ran its final day of service for the 2023 season on Monday, September 4th. The Zilker Shuttle kicked off May 27th and ran every Saturday and Sunday, during Memorial Day, the Fourth of July, and Labor Day holidays from 10:00 a.m. to 6:00 p.m. Over 2,700 riders utilized the free parking and shuttle service from One Texas Center to Zilker Park this season, an increase of almost 400% compared to the 550 riders that used the shuttle during its kick-off season, which ran June 25 through September 5, 2022. Significant marketing efforts were made to increase the success of the program, including radio spots on KUTX, social media posts and ads, banners and yard signs placed throughout the park, two large temporary electronic signs placed along Barton Springs Road, messaging on overhead electronic traffic signs throughout the city, eight weeks of overthe-street banner installations at four locations in the greater downtown area, pop-ups near Barton Springs Pool and Barton Creek distributing flyers and answering questions, and staff with spinner promo signage in the park on weekends. Additionally, the program was featured in local news including Community Impact, Austin.com, KVUE, KXAN Austin, Fox7, Austin Monitor, and CBS Austin. Districts 5 and 8




Park Rangers Contacts and Program Updates: The Austin Parks and Recreation Park Rangers reported 4,013 contacts with park visitors for the reporting period of Thursday, August 10th through Sunday, September 10th totaling 35,339 contacts for the entire fiscal year. During this timeframe, Park Rangers offered information, assistance, programs, and conservation services within parks maintained by the Department. Park Rangers handled daily operations including 2,350 contacts regarding laws, safety, service, and education. 146 contacts were logged for off-leash dogs during this timeframe, totaling 2,381 contacts with park visitors about off-leash dogs since October 2022. Park Rangers also conducted 25 programs totaling 64 hours with 1,663 participants. Programs focused on Leave No Trace recreational practices and responsible recreation.

ADMINISTRATIVE UPDATES:

Annual Desk Reviews: Contract Monitoring is an ongoing process throughout the term of the contract. An annual desk review of the contracts is performed to monitor compliance. Working collaboratively, the contract manager and contract staff utilize the scope of work and the agreement's terms and conditions in evaluating whether all contract requirements and deliverables are met. In evaluating compliance, close attention is given to requirements such as Living Wage and MBE/WBE Program Compliance. The annual review, along with the day-to-day monitoring, allows the contract manager to alert the contractor to any performance that deviates from the contract requirements. The information derived through desk reviews enables PARD to assess performance, identify any compliance problems,





determine need to renew or continue the contract or determine the need for an on-site review. For FY23, the PARD Contract Unit will complete approximately 300 desk reviews to fulfill the monitoring requirement. The associated contracts include, but are not limited to, master, interlocal, interdepartmental, parkland improvement, license, athletic field use and service agreements.

Zilker Train: After facing some challenges and setbacks, the Austin Parks Foundation has reported that their plans to restore the Zilker Train are officially back on track. Since their last social media post, they have partnered with a local group of engineers, who have the experience and expertise to deliver a safe, functioning train, and the work is already underway. The train coaches were recently transported to an off-site facility to be retrofitted with airbrakes to ensure they're safe for passengers. They'll also receive new electrical wiring for lights and a PA system. In August, APF provided an update on the train's operational progress. The Foundation has a website that provides details on opening and activities related to the train at https://www.zilkertrain.org.

Recreation Management System: In October 2022, the Department began working with a CTM project manager to establish timeline and deliverables for the solicitation scope of work. The solicitation was published on June 5, 2023, and was extended and closed on July 20, 2023. Six proposals were received, and all proposals were deemed responsive. The evaluation process, led by Central Procurement, is in process. The Department will continue to utilize RecTrac services throughout the solicitation process until a recommended vendor is established.

Watercraft Concession at 2418 Stratford Drive: Due to the cancellation of the solicitation by Central Procurement and the need to resolicit, the contract with the current vendor, Rowing Dock, was extended through October 31, 2023. Additionally, in July 2023, PARD staff requested that the Contracts and Concession Committee and Parks Board recommend City Council authorize an additional one-year contract extension with the Rowing Dock. The extension request that was recommended by PARB and approved by City Council on September 21, 2023. The additional one-year extension will assist the Department in providing quality recreation services while giving the City time to resolicit a concessionaire for the Stratford Drive location.

Zilker Café: A new solicitation was developed to operate and maintain the food and beverage concession on the north side of Barton Springs Pool in Zilker Park. The scope of work for the solicitation was presented to the Contracts and Concession Committee on May 19th, 2023, and published on May 30, 2023. Central Procurement held a pre-proposal meeting on June 8, 2023, and proposals for this solicitation were due by July 25, 2023, following a two-week response extension. One proposal was received, and Central Procurement is currently conducting the evaluation process.

Swim ATX: This agreement is an interlocal agreement with the Austin Independent School District (AISD) for SwimATX, a year-long swim lesson program that includes the 36-hour lifeguard certification course, which will be provided to the students of select AISD high schools. The interlocal agreement was presented to the Contracts and Concessions Committee on May 19, 2023, and was approved by the Parks and Recreation Board on June 26, 2023, and subsequently approved by Council on July 20, 2023. It will be presented to the AISD Board of Trustees in September.

Interment Services International: In June 2013, City Council approved a five-year contract, for \$3.8 million, with Interment Services International to provide interment and burial services for City of Austin cemeteries. In 2018 and 2021 respectively, with the direction to return to Council for approval of contract





extension options, City Council approved a three-year extension option and a two-year option. With one five-year extension option remaining, cemetery staff estimates the need to continue to outsource these services for another two years. The lingering economic conditions resulting from the pandemic created challenges and obstacles for Cemetery Operations to fully hire the necessary staff to train for the additional interment/burial services. In addition, the same complications resulted in longer than anticipated supply chain issues with purchasing and acquiring the necessary equipment and machinery necessary to perform these duties and to ensure proper staff training operations. At the end of the two-year period, the Parks and Recreation Department plans to transition all burial and interment services to City personnel. An extension to the contract allows staff time to absorb the increased responsibilities and duties associated with the mandated operational expansion along with current job duties and responsibilities. Without this extension, the contract for burial and interment services expires November 28, 2023. PARB recommended that Council approve the execution and negotiation of the amendment on August 28, 2023. The amendment is scheduled for Council action on October 19, 2023.

End-of-Year Deadlines for Financial Services: The FY2023 Year End Close process is underway. The Financial Services Division is in constant communication with PARD staff, addressing purchasing and accounting-related activities and their corresponding deadlines for the remainder of the current fiscal year. The deadlines, within the end-of-year schedule, are important to ensure any needed procurements are completed in time to utilize the current fiscal year funds, as well as ensuring the department's ability to manage the budget and fund balances.

City of Austin Financial Managers Forum: On a quarterly basis, the City of Austin Financial Services Department hosts a city-wide Financial Managers Forum to share financial information and best practices. The August forum included presentations on the following:

- Fiscal Year 2023 Year End Close procedures
- Travel advances
- UKG timekeeping system approval requirements
- New Bank Reconciliation Tools (Dashboards)
- Update on GASB 87 Lease Reporting Requirements

Hiring Success: PARD Human Resources Division for FY has had a successful year in hiring for regular employees as well as summer temporary employees. For FY 2023 The PARD HR Employment team reduced regular FTE vacancies from 156.5 (20.6%) to 90 (11%), below the City vacancy rate of 13.6%. In cooperation with Aquatics the Department successfully hired approximately 1,200 summer temporary employees which includes close to 1,000 lifeguards, which in turn not only allowed the City to open all pools, but also to keep several additional pools open through September. To date, the PARD HR Payroll team has successfully entered over 1,000 summer bonuses.

Greenbuild International Conference + Expo: Several staff members of the Department Development Division will attend GreenBuild in Washington DC from September 24 through September 29. Greenbuild is the world's largest green building conference and expo in the world. Multiple Department staff members attending hold positions on committees collaborating at the conference, including Engineer Sarah Talkington, chair of the LEED Steering Committee, Assistant Director Liana Kallivoka, who serves on the LEED Fellow Committee, and Division Manager Lindsey Machamer, who is part of the Resilience Working Group. Sarah Talkington will also present on LEED v5 Development at the conference on September 27. Staff will also attend meetings for the Sustainable SITES Initiative and the International WELL Buildings Institute.

National Recreation and Park Association Conference and Expo: Several staff members from various Divisions within the Department will attend the conference either in person (Dallas, Texas) or virtually from October 9th through October 12th. The National Recreation and Parks Association Conference is the premier event within the Parks and Recreation profession. Multiple Department staff members attending hold positions on committees collaborating at the conference, are presenting at the conference and/or are earning continuing education credits.
