5. Discussion and possible action to approve a recommendation to City Council to increase funding for respite beds across Austin and to address the health impacts of the homeless camp sweeps.
The motion to approve the recommendation on Medical Respite and Street Medicine that encourages the Austin City Council to allocate funds and explore all available resources in order to accommodate more beds with an emphasis on increasing beds for women and beds that accommodate pets; and recommends the Austin City Council direct Austin Police Department to work and coordinate directly with the Street Medicine Team to establish a protocol so that they can complete their health checks, case work and visits if their arrival intersects with APD sweep activities was approved

on COMMISSIONER DANIELA SILVA's motion, COMMISSIONER JESUS PERALES's second on an 8 – 0 vote (Absent: Commissioner Vanessa Maldonado)

6. Discussion on the Elevate program at EDD with possible action to recommend to city council to improve the program, including language access and outreach to Spanish speaking communities.
The motion to move this item to the Language Access Workgroup to discuss and draft a recommendation to City Council on the Economic Development Department's grant programs and foreign language accessibility was approved on COMMISSIONER DANIELA CASTAÑEDA's motion, COMMISSIONER LEONOR VARGAS's second on an 8 – 0 vote (Absent: Commissioner Vanessa Maldonado,).
7. Discussion regarding the Interim City Manager's Proposed Budget for FY23-24, with possible action to approve a recommendation to city council to postpone the impending changes to the Equity Office, Civil Rights Office, Small & Minority Business Resources, Office of Sustainability, and Resilience Office.
The motion to approve the recommendation to City Council to maintain the independent autonomy of the Equity Office, Civil Rights Office, Small & Minority Business Resources, Office of Sustainability, and Resilience Office was approved on COMMISSIONER LEONOR VARGAS's motion, COMMISSIONER JESUS PERALES's second on an 8 – 0 vote (Abstain: Commissioner Eliza May; Absent: Commissioner Vanessa Maldonado).
8. Discussion and possible action on a recommendation to City Council that requests a cost-of-living increase for all early childhood contracts. (Follow-up action item from the June 27th, 2023 regular meeting and presentation from Austin-Travis County Ready Families Collaborative.)
Commissioner Leonor Vargas also sits on the Early Childhood Council, and their meeting with early childhood service providers and homecare providers that demonstrated many financial struggles and concerns about reimbursement that is not enough to cover staff. This does impact the well-being of our families, economically, socially, physically, emotionally.
Council Member Vanessa Fuentes successfully passed a FY24 budget amendment to include a 20% increase to social service contractors that provide childcare services. Commissioners request City Council Member Vanessa Fuentes provide an update on how that increase has impacted Early Childhood services and resources. Commissioners also request an update from United Way, GAVA, and APH. Item tabled for six months, until February 2024.
9. Discussion on the 2024 Boards & Commissions Report on the departmental responses to B&C budget recommendation, including potential action to authorize additional commissioners to attend the Budget Workshop with department leadership hosted on Saturday, September 9th, 2023.
The motion to authorize Commissioner Ivanna Neri to attend the Budget Workshop on with permission to speak to other commissioners and city staff regarding the FY24 and

FY25 budget was approved on COMMISSIONER SHARON VIGIL's motion, COMMISSIONER DANILEA SILVA's second on an 8 – 0 vote (Absent: Commissioner Vanessa Maldonado).
