BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The zoning map established by Section 25-2-191 of the City Code is amended to change the base district from family residence-neighborhood plan (SF-3-NP) combining district, limited office-mixed use-neighborhood plan (LO-MU-NP) combining district, and limited office-mixed use-conditional overlay-neighborhood plan (LO-MU-CO-NP) combining district to townhouse and condominium-neighborhood plan (SF-6-NP) combining district on 1902, 1904, and 1906 Ullrich Avenue, and multifamily residence highest density-neighborhood plan (MF-6-NP) combining district on 1911, 2001, 2003, 2005, and 2007 West Koenig Lane, on the property described in Zoning Case No. C14-2023-0019, on file at the Planning Department, as follows:


