#### Call to Order.

BAC Chair Les Case called the Meeting to Order at 6:00 PM

#### **Public Communication.**

Jason Abels addressed the BAC and PAC on creating a cycle to school community in Mueller

#### I. Local traffic fatalities reported since previous meeting

PAC Vice-Chair Kimberly Levinson read aloud the names of people whose deaths due to traffic crashes on Austin streets were reported since the BAC and PAC last met:

Tuesday April 18, a bicyclist killed in the 1100 block of N Lamar; Tuesday April 25, unidentified pedestrian killed in the 3000 block of S FM 973; Saturday May 6, Lucas Aubry Barth, 31, in a single vehicle crash in the 13200 block of N IH 35.

BAC Chair Les Case recognized Lewis Leff, Austin Transportation and Public Works Department to present

BAC Chair Les Case asked about what the department considers riding in the freeway, Lewis Leff answered that it means someone is riding on general purpose freeway lanes

PAC Member Dayna Diven asked about how Vision Zero calculates per population deaths, Lewis Leff responded by saying they do not break the data down that way because their goal is zero deaths

A community member asked if they had correlated the data with speed limit, Lewis Leff explained they had and they found that higher speeds correlated to more traffic deaths

BAC Chair Les Case asked about missing data in the Vision Zero dataset, Lewis Leff discussed the difficulties of filling in data missing from official crash reports

# IV. Transportation and Public Works Department Organizational Structure Recommendation

BAC Chair Les Case recognized BAC Vice Chair Spencer Schumacher to present his draft recommendation.
