The applicant is requesting a variance(s) from the Land Development Code, Section 25-2-492 *(Site Development Regulations)* from Impervious Cover requirements to increase from 45% (maximum allowed) to 54.9% (requested) (53% existing), in order to erect a swimming pool to an existing Single-Family residence in an "SF-2", Single-Family Residence zoning district.
