Mission of the Austin/Travis County Sobering Center

The Sobering Center enhances public health and safety by providing a safe place for publicly intoxicated individuals to sober up as an alternative to the emergency room or jail and, where appropriate, to provide a bridge to recovery.









Numbers Served

The Sobering Center has performed almost 10,000 intakes since its inception.

Sobering Center of Austin

- No jail or emergency room
- No citations, fines, or medical bills
- No cost for Sobering Center services
- Open 24 hours/7 days a week
- Complete confidentiality
 - We do not notify anyone of a client's admission into the center without consent or subpoena
- Connection to community resources and other services
- Assistance with coordinating transportation home



Admission Criteria

- 18 years or older
- Suspected alcohol or drug intoxication
- No evidence of acute head injury
- No untreated lacerations
- No seizure within the last 24 hours
- No acute gastrointestinal bleeding
- Suicidal/homicidal ideation cleared by a MH professional



Outcomes FY23

- 128 seeking treatment (holdovers)
- 92% warm handoff

- 82 holds for referral partners
- 80% return to original care

Costs

Direct Costs, SC	\$ 1,682,536	\$ 848.05
Direct Costs, County	\$ 180,000	\$ 158.45
Direct Costs, EMS	\$ 9,012	\$ 4.54
Direct Costs, APD	\$ 13,277	\$ 6.69
Indirect Costs, EMS	\$ 173,195	\$ 87.30
Total Costs	\$ 2,058,021	\$ 1,105.03

- <u>Direct Costs, SC</u> costs borne by the Sobering Center to deliver its services
- <u>Direct Costs, County</u> foregone rent on SC facility
- <u>Direct Costs, EMS</u> medical supplies donated by EMS, EMS costs to transport clients to ER/hospital (non-admits and admit-transfers)
- <u>Direct Costs</u>, <u>APD</u> APD costs to transport clients to jail (non-admits and admit-transfers)
- <u>Indirect Costs, EMS</u> foregone reimbursement for patients transported to the SC rather than to an ER/hospital.
- Note: CBA includes only direct program costs. Full budget for SC is \$2,329,207
