3 **WHEREAS**, the Austin Public Library has a commitment to equity, to
4 assure that all members of the Austin community have equal access to library
5 services and programs; and

6 **WHEREAS**, the Austin Public Library has continuously sought ways to
7 remove barriers and close the opportunity gaps for library users; and

8 **WHEREAS**, currently, only Austinites living in Austin’s full purpose
9 jurisdiction are entitled to receive a library card free of charge and those who live
10 in the surrounding areas must pay a non-resident card fee of \$120 annually; and

11 **WHEREAS**, the non-resident fee affects people who live in Austin’s extra-
12 territorial jurisdiction (ETJ) and limited purpose jurisdictions as well as those who
13 work in Austin but live in the surrounding areas, including many former Austinites
14 forced to relocate due to ongoing gentrification and the increase in the cost of
15 housing; and

16 **WHEREAS**, the non-resident card fee poses an economic barrier to library
17 access, which does not recognize that the community of Austin includes many
18 people with addresses outside of Austin’s full purpose jurisdiction; and

19 **WHEREAS**, the ETJ is the unincorporated land within five miles of
20 Austin’s full purpose city limit that is not within the city limits or ETJ of another
21 city; and

22 **WHEREAS**, the ETJ is the territory where Austin alone is authorized to
23 annex land and represents the City’s potential growth boundary both with respect
24 to its future tax base and municipal service area; and

25 **WHEREAS**, the City’s ordinances and regulations pertaining to land
26 development and the environment, and sometimes health and safety, are extended
27 to Austin’s limited purpose jurisdictions, and residents of limited purpose
28 jurisdictions can vote in City Council elections; and

29 **WHEREAS**, providing access to Austin Public Library resources, including
30 literacy advancement, workforce and economic development, digital inclusion,
31 science, technology, engineering and mathematics, and computer training to
32 persons residing in Austin’s limited purpose jurisdictions and ETJ satisfies a public
33 and municipal purpose, as it benefits the entire City through a more literate,
34 informed, and skilled populace; and

35 **WHEREAS**, between 2008 and 2015, state funding allowed the Austin
36 Public Library to waive the non-resident library card fee for people who live
37 outside of Austin; and

38 **WHEREAS**, the Austin Public Library created the Library Cards for All
39 Students Program in 2017 in which they partnered with the Austin Independent
40 School District to offer a full-purpose Student Library Card to students, and
41 onboarded the Del Valle Independent School District to the program in 2019,
42 Austin Achieve Public Schools in 2021, Austin Montessori School in 2022, and
43 Manor Independent School District in 2022 to offer a full-purpose Student Library
44 Card to all students enrolled in those schools; and

45 **WHEREAS**, on December 17, 2020, the Library Commission
46 recommended that the City give student library cards at no cost to every student in
47 Travis County enrolled in a K-12 educational institution or home school; and

48 **WHEREAS**, on August 11, 2021, Council adopted the City’s 2021-2022 fee
49 schedule (Ordinance No. 20210811-002), which exempted children who are
50 currently enrolled in any school within Travis County, including private school,
51 daycare, charter, and home school students, from the non-resident library card fee,
52 and have continued that exemption in the City’s 2023-2024 fee schedule
53 (Ordinance No. 20230816-007); and

54 **WHEREAS**, on November 27, 2023, the Library Commission voted to
55 recommend to Council to expand library access by eliminating the non-resident fee
56 for those who live in the City's limited purpose and extraterritorial jurisdictions;

57 **NOW, THEREFORE,**

58 **BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

59 City Council adopts the findings above.

60 **BE IT FURTHER RESOLVED:**

61 The City Manager is directed to bring an ordinance to Council for approval
62 no later than the March 5, 2024, Council meeting to amend the fee and fine
63 ordinance (Ordinance No. 20230816-007) to remove the non-resident library card
64 fee for residents of the Austin limited purpose jurisdictions and Austin ETJ from
65 the fee schedule.

66 **BE IT FURTHER RESOLVED:**

67 The City Manager is directed to consider developing a comprehensive

70 outreach and promotion plan to inform residents of limited-purpose jurisdictions
71 and the ETJ about the changes and encourage library card registration.
